#### **APPENDIX A, MINIMUM QUALIFICATIONS, PARAGRAPH 4**

Bidder has provided roadway re-alignment, intersection improvements, drainage, stormwater management, and new mast arms with intelligent transportation components for at least four (4) projects since January 1, 2019, in which each project included the following components: (i) Drainage; (ii) Flexible Paving, (iii) Grading; (iv) Grassing, Seeding, and Sodding; (v) Guardrail; (vi) Hot in place Resurfacing Milling; (vii) Intelligent Transportation Systems;

(viii) Pavement Marking; (ix) Traffic Signal; (x) Sidewalk. Project clients must be agreeable to responding to an inquiry by the County.

# **QUESTIONS AND RESPONSES:**

- Q1. Your instructions to bidders, page 23, item 4 states that bidders must be a Florida Department of Transportation Prequalified Contractor in various classes of work including (vi) Hot in place Resurfacing. I'm unable to find any such work either in the plans or the bid pricing form. I believe this category may have been mistakenly added as (ii) Flexible Paving will be used and is included in your list. Please let me know where to find this work. If this category is not included in this project, for clarity, we request this it be deleted.
