QUESTIONS AND RESPONSES:

- Q1. Terracon is an engineering firm with the requisite experience, with licensed engineers, architects and Registered Roof Consultants, and Registered Roof Observers on staff, we have a valid Engineering License. We have performed roof inspections for numerous counties in Florida, successfully helping those counties with their Roofing Inspection needs. Can we submit on this RFP in lieu of being a "certified" roof contractor and not have a valid Certified Contractor's License as specified in 1.03 General Requirements (B) of the Solicitation Package?

- Q2. Approximately how many roofs are we looking?
- R2. Although the County is responsible for hundreds of structures with roofs, the Property Management Department estimates 10 to 20 roof inspection requests per year. Roof inspection services shall be requested on a as-needed basis.
- Q3. Who was the roofer doing this before?
- R3. Peach State Roofing.
- Q4. We are an Engineering Form licensed in the state of Florida (our local office is in Tampa Bay) that specializes in roofing and waterproofing, from roof designs, roof

- management and roof inspections. Would the County entertain ITQ responses from such highly qualified firms such as ours (roof consulting firms) or will you only accept ITQ responses from roofing contractors?

- Q5. As written, Manatee County will establish contracts with a roofing contractor to provide roof inspection services. Will the County accept bids from a roof consultant which typically provides unbiased third-party assessments precisely as outlined in the scope of work?

- Q6. Is the RFQ intended for Roofing Contractors, or can submissions be prepared by Architects, or Engineers that specialize in Building Envelope Consulting? (Roof, Walls, and Windows).
