BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

Manatee County is involved in many projects throughout the County. These projects may include but are not limited to widening of roads and intersections, traffic signals, and stormwater drainage. At times, the projects may require the County to acquire additional right-of-way easements, fee-simple title to parcels of land and other real property interests. The County additionally acquires fee simple title, easements and other various real property interests for reasons including but not limited to public parks, wetland mitigation and conservation easements. These acquisitions require title services based on the specific project and reason for acquisition including but not limited to title search and examination, title search reports, specific purpose reports, right of way reports, updated title search reports, easement reports and ownership and encumbrance reports. Other services needed may include Owner's policy, simultaneous mortgage policy, closings, 2nd mortgage closings, recordings, endorsements, Florida Form 9, joinders/partial releases, 30 year chain of title searches and court testimony fees.

SOLICITATIONS:

The RFP was advertised on the Manatee County website, DemandStar, and was also provided to the Manatee County Chamber of Commerce for release to its members. Three (3) proposals were received.

There was one Manatee County firms directly solicited and none that submitted a proposal.

EVALUATION RESULTS:

The Evaluation Committee convened on November 4, 2014 and and discussed the offers based on the stated requirements in the RFP, continuing the acquisition process, and determining a recommendation to the County Administrator. The Evaluation Committee voted based on the content of the proposals submitted and selected to request authorization to commence negotiations with the two selected firms.

The two firms selected all have all demonstrated the qualifications and capabilities to perform the work in the Scope of Services, resources to meet the needs of Manatee County, extensive knowledge base of all types of title related and closing services required by the County. All the firms have performed a high volume of title work within Manatee County.

REMAINING RESPONDENTS:

The remaining respondent, although well qualified, was not selected based on a comparison of capabilities of the selected firms.

ESTIMATED COST OF SERVICES: The estimated average annual expenditure is \$50,000.00
