QUESTIONS AND RESPONSES:

- Q1. Clarification on estimated annualized revenue for calendar year 2018, broken down into: Total Bar Revenue, Total Concession Revenue, and Total Catering Revenue (to include In-House Catering and Outside Caterers).
- R1. The revenue listed below is for Convention Center ONLY. The information provided is for the period (10/01/2017 thru 09/30/2018) which is the County's fiscal year FY2018.
 Convention Center Total alcohol sale revenue: \$39,041
 Convention Center Total concession sales: \$132,159
 Convention Center Total catering sales: approximately \$413,766 (calculated from 12 % commission by Milan and 15% by other caterers).
- Q2. Will the BACC be forecasting sales to be up or down in the three sectors; bar revenue, concession and catering revenue?
- **R2.** The BACC is projecting an increase in sales for the listed sectors and booked events.
- Q3. Can you provide the breakdown of alcohol sales at the BACC versus concession sales, are the bar concessions differentiated by 18% commission versus 12% on food?
- R3. See response R1 for the breakdown. The alcohol commission will be under contract for 20%

Q4. Will the documentation for the PCI Data Compliance Letter 2018 be sufficient to submitted for the requested information outlined in Exhibit 2, Section C, Tab 2, item 12 and Section H, Tab 7, Item 13, PCI Compliance measures?

R4. Yes, as long as it meets the requirements as outlined in the RFO for PCI documentation and the responses answer or provide support to each item asked or requested.
