However, test cuts will not be allowed for this Bid and information from previous cut samples regarding composition of the existing roof material to be removed will be provided in an upcoming Addendum.

Inspection of the site is **mandatory** to be considered for award of this Bid. Several potential Bidders have requested to perform a site visit and since access to the construction site is located within a secure facility, the following date and time has been scheduled for interested Bidders and their Subcontractors to be escorted to the construction site by County staff for the examination of site conditions:


2. **CHANGE** the Due Date and Time to **Friday, January 17, 2014 at 3:00 PM.**
