 - **Ranked #1**, Southeastern Telecom is locally stationed and has proposed no use of subcontractors and is the incumbent for this contract and satisfactory performs the services to date.
 - **Ranked #2**, Shared Technologies did not provide specific information relating to the qualification of technician(s) to be servicing the County.
 - Ranked #3, Optus, Inc. proposed the use of subcontractors for all areas of work.
