BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

Manatee County requires professional solid waste collection, recycling, special waste and reduction programs to assist the County with a variety of solid waste related services.

The Consultant performs, as required, all of the services necessary for the various solid waste projects. Projects may include a variety of tasks associated with planning, evaluation, development, and implementation of solid waste collection, recycling, special waste and reduction programs. Experienced technical expertise and assistance are required in the performance assessment of existing programs, expansion of programs, new initiatives, public education and outreach, and reporting requirements on an as needed, assignment by assignment basis. The consultant shall also provide miscellaneous services and support to the Department which may include presentations to the Board of Commissioners, other government entities. citizen groups, and regulatory agencies.

SOLICITATIONS:

EVALUATION RESULTS:

The initial evaluation committee meeting was held to discuss procedures and responsibilities of evaluation committee members, the proposals received and subsequently, developed a shortlist for oral presentations which consisted of Kessler Consulting Inc., Tampa, FL and SCS Engineers, Tampa, FL

Oral presentations were delivered to the Committee on July 18, 2016 by the two (2) shortlisted firms. The Committee continued the acquisition process with the committee's recommendation to County Administrator by recommending Kessler Consultants Inc.

Kessler Consultants, Inc., Tampa, FL – Kessler Consultants demonstrated exceptional qualifications in their proposal and oral presentation. The firm provides an organization that has vast experience in Florida markets (28 years) and is familiar with the County's solid waste goals and objectives due to their years of experience with the County. Additionally, the firm detailed its approach to the County's upcoming waste haulers acquisition which was innovative, yet practical; a support staff that adds value to all levels of the firm's performance; and has always expressed a willingness to work with the County meeting its solid waste needs and objectives.

SCS Engineers, Tampa, FL – SCS's presentation supported their experiences and expertise as described in their proposal and delivered satisfactory oral presentation. Highlights of the evaluation committee comments include staff in Tampa that could conduct projects in house and has additional resources throughout the US should there be a need. The firm provides similar services to the City of West Palm Beach, FL and Santa Rosa County, FL. However, they were not evaluated as high as the selected firm.

REMAINING RESPONDENTS:

The remaining respondent, although well qualified, were not selected based on a comparison of capabilities of the selected firms.
