**Q1. There are items on page 21, Section 1.04 Service Requirements, K – Special Services, that need some clarification and/or we will need to take exception to.**

**(a) Special Needs Shelter - assistance with Health Department staff in setting up oxygen distribution equipment on LOX tanks.**

R1(a). Assuming that you are taking exception to this, this is a requirement that must be provided by the awarded firm.

**Q1(b). 4-hour window?**

R1(b). Assuming that you are asking for clarification on the delivery requirements for emergencies, yes delivery within a four-hour window is a requirement.

**Q1(c). 12-hour window after hours?**

R1(c). Assuming that you are asking for clarification on the delivery requirements for normal deliveries, yes delivery within a 12-hour window is a requirement.

**Q1(d). Customer owned or Vendor owned.**

R1(d). Assuming you are asking for clarification, yes, these are Health Department owned four existing tanks.

**Q1(e). 125 D and 125 E vendor owned?**

R1(e). Assuming that you are asking if these two items are provided by the awarded firm, the answer is yes.

**Q1(f). Store Manatee County owned 4 VGL's/dewars at vendor location?**

R1(f). Assuming you are taking exception to this, the awarded firm will be required to store and provide maintenance for four County owned dewars.

**Q1(g). Emergency - deliveries throughout the duration of the declared Emergency within 4 hours of notification by the County?**
