BACKGROUND/EVALUATION

The Scope of Work will consist of the rehabilitation of sewage lift stations and manholes, wet well liner installation, repair, and replacement; wet well cleaning; and the replacement of discharge piping, fittings, valves, swing check valves, guide rails, pipe bracings, base ells, and mounting plates.
