

This memorandum serves as notification to the Procurement Division to cancel IFB#16-01380V, Gulf Drive Passenger Shelter project for the construction and installation of Passenger Shelters on Anna Maria Island, Bradenton Beach and Holmes Beach.

First, the bids received on March 23, 2016 were significantly higher than the Independent Cost Estimate (ICE) for this project. Second, a new shelter design is requested by the City of Anna Maria to match the shelters recently constructed by the Florida Department of Transportation (FDOT), during the sidewalk project on Gulf Drive. Staff is engaged now in additional due diligence to provide updated specifications and drawings for the new shelter design and to provide a new ICE if necessary, based on these items; and then the procurement will be reissued.

This project is currently under review, the specification/ICE and update process underway. Upon completion of the new design, MCAT will re-issue the request for construction of the Gulf Drive Passenger Shelter project.
