#### **QUESTIONS AND RESPONSES:**

- Q1. Please clarify what you are looking for on Item No. 7 (Exhibit 3, Quote Form, Page 29). I am not understanding what you are looking for with the description versus the extended price.
- R1. Exhibit 3, Quote Form, Item No. 7 is the Bidder's percentage of markup over their cost (cost plus markup) for building supplies, debris disposal, and miscellaneous materials; the Bidder's markup percentage shall not exceed 10%. Bidders shall complete the

Quote Form by listing their Unit Price (percentage of markup over cost) and Extended Price (percentage of markup over cost multiplied by \$100).

- Q2. Page 20, Items K and M mention an enclosed Hold Harmless Agreement. I did not see it attached, would you kindly send me a copy to review? Also, the Hold Harmless Agreement is only required to be signed and provided at the contract phase, correct?
- R2. Per this Addendum No. 1, Section 9.0 Insurances, Paragraph I Insurance Requirements, General Insurance Provisions Applicable to All Policies, Item K has been deleted and is no longer incorporated in the ITQ. Item M has been modified to remove the Hold Harmless Agreement requirement.

NOTE: Items that are struck through are deleted. Items that are <u>underlined</u> have been added or changed. All other terms and conditions remain as stated in the ITQ.
