NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Woodruff & Sons, Inc. for the provision of Water Main Upgrades – Willow Woods & Lake Estates.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/EVALUATION

The Scope of Work consists of the construction of approximately 6000 linear feet of two-inch, four-inch, and six-inch diameter water main by direct bury and/or jack and bore in the right-of-way, including all appurtenances such as hydrants, service lines, meter boxes, and pavement repair, Maintenance of Traffic (MOT), sod and surface restoration, coordination with County staff and residents, dewatering and all associated work.

The solicitation was advertised on October 25, 2019 on the Manatee County website and DemandStar. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release of its members and in the Tempo News and Bradenton Herald newspapers.
