### NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to negotiate a contract with Woodruff & Sons, Inc. for the provision of Design Build Services for Master Lift Station 5 Force Main Extension to Master Lift Station 1-M.

### ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

### BACKGROUND/EVALUATION

The County requested proposals from qualified firms for the provision of Design Build Services for the Master Lift Station 5 Force Main Extension to Master Lift Station 1-M project to include site work, survey, engineering design, and construction services under a single prime contract with a guaranteed maximum price (GMP). The Design Builder will provide all labor, materials, and equipment for the design and construction of the extension of the existing 20" diameter force main from 119th Street West to Master Lift Station 1-M along the Cortez Road corridor in Bradenton, Florida to include any required modifications to the existing gravity sewer lines and lift stations as a result of the force main extension.

The solicitation was advertised on the Manatee County website, and Bid Sync. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release to its members, and in the Bradenton Herald and Tempo News newspapers.
