Eight (8) supplemental suppliers were added to the plan holders list. Fifty-eight (58) plan holders downloaded copies of this bid. A total of sixteen (16) actual bids were received.
- Blanket Purchase Order will be issued to all bidders for each item bid. Award shall be
 determined per project/release order to the bidder with the lowest total offer based on the
 County's quantity estimate for each item required multiplied by the bidder's unit price.
- The Bidder's timely response under the terms of this contract is paramount. The
 unavailability of the lowest bidder (depending on the urgency of the County's needs), may
 result in the award/project being authorized to the next low bidder.
