QUESTIONS AND RESPONSES:

- Q1. Related to the page count for individual sections listed in section B.02 Response Format in the RFQ, will the County allow double-sided pages to count as one page?
- R1. The County will allow double-sided pages in Tab 7 Approach to Engineering and Tab 8 Organizational Structure and Capacity only. Please keep in mind overly elaborate response are not requested or desired; information supplied should be relevant to this project.
- Q2. Could you please clarify the proposed schedule for the overall project including design and construction (Attachment A, 1.07 and Attachment B, G.TAB7.3). Based on our experience with similar projects in Southwest Florida, 24 months from kickoff to substantial completion of the project is inadequate. We typically see an overall schedule of 40 to 44 months.

R2. The County's expectation is to have 100% design complete within 24 months.

Q3. Does the County require the construction of the expansion to be substantially complete in 24 months or the 100% design?

R3. The County's expectation is to have 100% design complete within 24 months.

Q4. Are 11" x 17" pages allowed? If so, are they just to be used for Graphics? Do they count as one or two pages?

R4. Yes, 11" x 17" pages are allowed, can be used as Proposer deems necessary, counts as one (1) page.

Q5. Please confirm Tab 9 is limited to 15 pages (1 page for each of the project examples...a limited of 15 example projects.

R5. Tab 9 is limited to 15 pages; the pages can be utilized however the Proposer deems helpful.
