- Q2. Has a study been done yet to verify the 40,000 sqft? If so, can we get a copy of it?
- R2. A study has not been performed.
- Q3. Has a civil engineer been helping with any of the preliminary site information? If so, can you send the name of the civil?
- R3. No civil engineer has been assisting.
- **Q4.** May we have a copy of the pre-proposal conference presentation?
- R4. See response to R1.
- Q5. Can you supply a copy of the non-mandatory info conference sign-in sheet?
- R5. Sign-in sheet attached to this Addendum No. 1.

Q6. Can you please confirm what the total design and construction budget is (or is expected to be) that has been assigned for this project in relation to answering and signing an authorized official letter 'to meet the commitment of the County's time and budget requirements' per item #7 on Page 55 under Tab 7?

Pg. 55, Tab 7, Item #7

- "7. Provide a statement on company letterhead and signed by an authorized official of Proposer attesting to its commitment to meet the County's time and budget requirements for all assigned work."
- R6. Per CIP #6108500 Total Budgetary Cost Estimate is \$6,780,000.00.
- Q7. The County's Capital Improvement Plan has the total project budget of \$6,780,000. Does the County plan on acquiring sufficient funds for the design and construction being that they require a 45,000 SF highly secure facility with crime scene unit, chemistry lab, figure print unit, evidence storage, and administrative/office space?
- R7. Additional funding will be requested as needed.
- Q8. Has a programming study has already been performed for this project? If so, can we get a copy of the programming study?
- R8. A programming study has not been performed. This will be performed by the chosen architect and Owner.
- Q9. Will a bid bond be required for any work under this contract? Will a payment and performance bond be required?
- R9. Bonding requirements sections are not checked, which implies they are not a requirement for this Request for Qualifications, nor will they be a requirement of the final agreement.
- Q10. Article 25 of the PSA specifically states that individuals performing under the contract are responsible for their negligence, errors and omissions, not just the company. Would the County consider inserting the statutory exception for individual liability, or at a minimum reduce individual liability to negligent acts?
- R10. No.
- Q11. Page 45 references soil testing as required: will the County consider contracting separately for service related to required soils testing? Is information available form previous studies or testing?
- R11. The selected architect will be responsible for the Geotechnical Soils Investigation.
- Q12. Will the County provide a project program that provides additional detail of the information depicted in 1.02 as I program validation a required service?
- R12. See response to R8.

Due Diligence Review of Proposals

- Due diligence review: proposals are evaluated to determine whether each Proposer is responsible and responsive.
 - A responsible Proposer is a Proposer which the County affirmatively determines has the ability, capability and skill to perform under the terms of the agreement. One who meets the minimum qualification requirements of this RFQ.
 - A responsive Proposal is one that follows the requirement of this solicitation, includes all documentation, is submitted in the format outlined in this Solicitation, is of timely submission, and has the appropriate signatures as required on each document.
 - Proposals that are deemed non-responsible and/or non-responsive will not be considered or evaluated.



Minimum Qualifications

- Proposer must be registered with the State of Florida. Division of Corporations to do business in Florida.
- Proposer must possess current, valid licenses and certifications required under Florida Statue to perform engineering or architectural services as applicable to the Manatee County Sheriff's Office Property Evidence Building project.
- Proposer or its subconsultant has completed (certificate of occupancy has been issued) a minimum of three (3) projects similar in scope included in the RFQ since January 1, 2011.



Minimum Qualifications (Continued)

- Proposer is not on the Florida Suspended, Debarred, Convicted Vendor, Excluded Parties or Scrutinized list of Prohibited Companies lists.
- If you are filing as a joint venture, provide the firms approved filling with the DBPR.
- Must have no reported conflicts of interest in relation to this RFQ.
- Complete Forms 1 through 9 included in RFQ.
- Proposer provides a Response that conforms to the material aspects of Exhibit 2.

 The contents of each Response shall be organized and arranged with tab numbers and tab names in the same order as listed in the RFQ and with the same TAB names and numbers. The Response should contain sufficient detail to permit the County to conduct a meaningful evaluation. However, overly elaborate responses are not requested or desired. Background

- The County is requesting proposals from qualified firms for the provision of professional architectural / engineering services for the Manatee County Sheriff's Office (MCSO) new property evidence building.
- Construct a new 40,000 square foot two-story building adjacent to the existing Child Protection Investigation Division (CPID) office building located at 3500 9th Street West, Bradenton. The building should house the Fingerprint Unit, Crime Scene Unit, Chemistry Lab, Evidence Storage, Administrative Area and Facilities.
- The objective of this solicitation is to provide all planning, design, permitting, cost options and project management for the Manatee County Sheriff's Office evidence building which will be constructed at the following location:

3500 9th Street West

Scope of Services

Project Description-

The successful Proposer (hereinafter in this scope referred to as Consultant) shall provide all labor and materials for the design of the MCSO Property Evidence Building project which includes, but not limited to, the following:

- Fingerprint Unit
- Crime Scene Unit
- Chemistry Lab
- Property and Evidence Spaces
- National Integrated Ballistic Information Network (NIBIN) Space
- Administrative / Facility Spaces



Project Scope (continued)

- The facility shall meet standards outlined in the Property Management's Preferred Building Design and Product Catalog Latest Addition, the Department of Justice ADA Standards for Accessible Design and the latest edition of the Florida Building Code Other jurisdiction entities include, but not limited to, Southwest Florida Water Management District, State of Florida Department of Environmental Protection, and Manatee County Health Department and the Department of Agriculture.
- Further, the design of the project must be designed to meet the minimum standards established for "Silver" LEED certification, however the County does not intend to pursue such certification. The A/E is required to provide documentation of the LEED Silver design efforts, no tracking or monitoring is required.



Estimated Project Completion Date & Project Cost

- Estimated completion date for the 100% design submittal is eight (8) months from Board of County Commissioners contract award or Notice to Proceed.
- The current approved Capital Improvement Plan (CIP) construction budget is \$4,952,000.00.

Trade Secrets

- Proposers must identify any trade secret being claimed in accordance with Florida Statute 812 and the instructions in the RFQ.
- Designation of the entire Proposal as 'Trade Secret', 'Proprietary' or 'Confidential' is not permitted and may result in a determination that the Proposal is nonresponsive and therefore will not be evaluated or considered.



Insurance Requirements

Coverage limits of not less than:

- Automobile: \$2m / combined single limit; or \$1m Bodily Injury and \$1m prop damage; \$10k No fault; \$500k non-owned and \$10k medical payments.
- General Liability: \$1m /single limit per occurrence; \$2m aggregate;
 \$2m products; \$1m personal / advertising injury; \$100k fire damage;
 \$10k medical expense and \$1m third party property.
- Employer's Liability: \$100k each accident; \$500k disease each employee; \$500k disease policy limit and Workers Compensation Insurance.
- Professional Liability and/or Errors and Omissions (E&O) Liability: \$3m bodily injury and property damage each occurrence; and \$3m general aggregate.



Mistakes That Could Cost You!

- Delivering the response after the deadline.
- Failing to provide the information requested for the "Minimum Qualifications".
- Not presenting questions regarding minimum requirements, scope/specifications, terms and conditions, or other provisions prior to the deadline for delivery of questions, which include questions about the insurance coverages and the sample agreement attached to the RFQ.
- Providing information that is not legible, too small or blurry.
- Failing to acknowledge addenda.
- Failing to sign the response.
- Failing to have insurance coverages at expected limits.
