Due Diligence Review of Proposals

- Due diligence review: proposals are evaluated to determine whether each Proposer is responsive and responsible.
 - A responsible Proposer means a Proposer meets the minimum qualification requirements of this RFQ.
 - A responsive Proposer means a Proposer has submitted a Proposal that conforms in all material respects to the requirements in the RFQ.
 - Proposals that are deemed non-responsive and/or non-responsible will not be considered or evaluated.



Minimum Qualifications

- Proposer must be registered with the State of Florida. Division of Corporations to do business in Florida.
- Proposer must possess current, valid licenses and certifications required under Florida Statutes to perform Construction Manager at Risk Services.
 - ✓ Certified under Section 489.119, Florida Statutes, to engage in contracting through a certified or registered general contractor.

OR

✓ Proposer must be a Florida Department of Transportation (FDOT) Pre-Qualified Contractor in the Category of "Intermediate Bridges" or "Flexible Paving".



Minimum Qualifications (Cont.)

- The Proposer shall have completed, as a CMAR or as the prime contractor, at least three (3) roadway projects for different clients that included each of the following components: flexible paving, stormwater and drainage systems, sidewalks, underground water or sewer utilities, street lighting, and ATMS with a contract value exceeding five million dollars (\$5,000,000) since April 1, 2012.
- Proposer or Proposer's subcontractor has provided bridge construction services for at least three (3) clients since April 1, 2012.
- Requirements for submittal of information related to projects meeting criteria are outlined in Tab 6, Item 1, and shall be submitted under Tab 6 rather than this Tab 2.



Minimum Qualifications (Cont.)

- Proposer not listed on the Florida State Board of Administration, Scrutinized List of Prohibited Companies.
- Proposer not on the Florida Suspended or Debarred Vendor list.
- Proposer not on the FDOT Contractor Suspended list.
- Proposer not on the Federal Convicted Vendor or Excluded Parties list.
- If a proposing as a Joint Venture, provide documents under F.S.
 489.119 or provide a statement of non-Joint Venture filing.
- Proposer has no reported conflict of interests relating to the RFQ.
- Proposer or its representative(s) attended one (1) of the mandatory site visits offered.
- Proposer submits letter on co. letterhead that Proposer or its representative(s) has made a visit to the remainder of the construction area.
- Complete Forms 1 through 9 included in RFQ.



Proposal Response

- The information each Proposer provides will be used to determine the Proposer with the background, experience, and capacity to perform the scope of services as stated in this RFQ and which Proposer best meets the overall needs of the County.
- The contents of each Response shall be organized and arranged with tabs in the same order as listed in Exhibit 2. The Response should contain sufficient detail to permit the County to conduct a meaningful evaluation. However, overly elaborate responses are not requested or desired. Single-side Page Limits Per Tab.
- Tabs must be arranged in the same order as listed; numbered and named.

Trade Secrets

- Proposers must identify any trade secret being claimed in accordance with Florida Statute and the instructions in the RFQ.
- Designation of the entire Proposal as 'Trade Secret', 'Proprietary' or 'Confidential' is not permitted and may result in a determination that the Proposal is non-responsive and therefore will not be evaluated or considered.
- Trade secret material must be segregated from the portions of the Proposal that are not being declared as trade secret.



Background

- The purpose of this Request for Qualifications (RFQ) is to solicit responses from qualified firms or individuals to provide CMAR Services for the 44th Avenue East – I-75 to Lakewood Ranch Blvd and SEWRF East Lake Expansion project (Project). Proposers should have an established reputation and documented successful experience in providing CMAR services or as a prime contractor. The Proposer selected is expected to have appropriately experienced staff in sufficient quantity and availability, and resources to provide comprehensive, reliable products and services regarding the Project and will be required to demonstrate this via the submittal documents and/or associated interviews, if deemed necessary.
- The Project has an estimated construction value of sixty-eight million (\$68,000,000) dollars.



General Requirements

The successful Proposer will provide the following:

- 1. Pre-construction services prior to the start of the Project, as described in Section 1.04.A of this RFQ.
- 2. Solicit bids from subcontractors to perform the work of the Project and to establish a Guaranteed Maximum Price (GMP).
- 3. Serve as the general contractor during the construction phase of the Project and be responsible for construction means and methods.
 - 1. Manatee County (County) will compensate the selected CMAR for Pre-construction services based on a not-to-exceed negotiated fee.
 - 2. The County will compensate the CMAR for construction services based on an accepted GMP established between the parties using an open-book process for identifying all costs for the Project. A schedule of values shall be developed that is acceptable to both parties for review of bid package elements, self-perform components and the CMAR fees for the Project.



Project Description

The 44th Avenue East – I-75 to Lakewood Ranch Blvd and SEWRF East Lake Expansion project includes construction of approximately 1.6 miles of a new 4-lane divided roadway extension of 44th Avenue East from west of Interstate 75 to Solutions Lane, west of Lakewood Ranch Blvd. Included is a 380-foot long bridge structure over I-75, approximately 1,700 feet of causeway within the existing Countyowned reclaimed water storage lake, a roundabout at the intersection of Lena Road, sidewalks, bike lanes/multi-use path, street lighting, ATMS, stormwater management, drainage systems, underground water and sewer utilities, and other improvements as shown in the construction plans. Approximately 1,400 feet of 2-lane divided roadway with sidewalks, multi-use path, street lighting, stormwater management, drainage systems, and other improvements, as shown in the plans, will be constructed to connect 44th Avenue East to the existing Lena Road located to the south. An offsite wetland mitigation site will be constructed at the County-owned Hidden Harbor Park that is located on the north side of the Bradenton River, immediately adjacent to the east side of the Fort Hamer bridge. Lastly, the existing County-owned SEWRF East Lake reclaimed storage lake will be expanded and will provide a source of fill material for this project as well as additional reclaimed water storage volume for the SEWRF.
