In The Drawings

Sheet M-1. Notes.

Add: 5. Contractor shall supply one 10 pound ABC type fire extinguisher in a heavy duty outdoor cabinet (model A-HDOC-10 by Strike First or equal) mounted on the northern most support of the Electrical Equipment Rack.

Sheet E-3. Reference Note 7.

Add: Provide permanent plaque mounted to panelboard with contrasting colors and minimum on 2-inch high lettering that states, "Generator Backed."

Sheet E-3. Reference Note 11.

Add: Provide permanent plaque mounted to panelboard with contrasting colors and minimum on 2-inch high lettering that states, "Generator Backed."

Sheet E-5,

Delete "Reference Note 10" in its entirety.

Sheet E-7, Panel "PPG" and "MDP" Tables

Delete the "Nema 12" rating and replace with "Nema 4X Stainless Steel".

Section 16236, Emergency Generator System

Paragraph 2.5, N, Generator Accessories

Add: Provide isolation valves for the fuel filter/water separator as recommended by the manufacturer.

Paragraph 2.9, Fuel Piping and Valves

Add: G. Provide shut-off valve on fuel supply line just prior to the line entering between the generator rails, such that the location is accessible, but not directly in the walkway. Fuel supply shut-off valve shall be labeled as such.

Question 1: REF: B.02 "Florida GC License" - Does the contractor have to be form Florida? I do not recall

any previous bids listed this way.

Response 1: Contractor shall have a Florida GC License.

Response 2: Patch fiberglass lining (typical of 3) is correct. The existing manhole also has a fiberglass

Question 1: Which publication are we to use for electrical conduit types, Specifications section 16130 or notes on drawings E-2 and E-5.

Response 1: Electrical conduits shall be in accordance with the electrical contract drawings E-1 through E-7.

Question 2: Is panel MDP to have a NEMA-12 enclosure as indicated on Sheet E7 or NEMA-4X-316SS as indicated on Sheet E3, note 7 or is the intent to install a NEMA 12 panelboard in a NEMA-4X-316SS enclosure?

Response 2: All of the equipment on the rack shall be in Nema 4X Stainless Steel enclosures except for the utility meter. The utility meter shall meet the utility guidelines and regulations.

Question 3: Is panel PPG to have a NEMA-12 enclosure as indicated on Sheet E7 or NEMA-4X-316SS as indicated on Sheet E3, note 7 or is the intent to install a NEMA 12 panelboard in a NEMA-4X-316SS enclosure?

Response 3: All of the equipment on the rack shall be in Nema 4X Stainless Steel enclosures except for the utility meter. The utility meter shall meet the utility guidelines and regulations.

Questions from Randy Wyatt, submitted 12/8/08 via email

Back on July 30, 2008, I provided a budgetary quote to URS for this project. The following Question 1:

programming services (in italic) were included in the quote:

"Master Lift Station 41-A TCU CODE

During the event when the generator run status is detected by the TCU it will limit pump operation to a lead and lag algorithm. Should the lag 2 pump be called to run or is currently running when the generator run status is detected it will be prohibited to run or called to stop. Once the generator run status has cleared the lag 2 pump will be allowed to run as required. Further modifications to the TCU code will also be made to display both system flow and pressure."

I cannot find in the current project plans that these programming services are required now. I

just want to make sure that that is the case.

The intention of the TCU Code modification is to disable the use of the lag 2 pump while the Response 1: ATS is in the "back-up" position. The generator is sized to operate a maximum of two 50 Hp

pumps in addition to the site's non-pump loads.

Sheet E-2, Reference Notes 9 & 16 indicate a light is to be mounted on the antenna tower Question 2:

assembly. Please be aware that DFS does not provide, install, or recommend any light fixtures

be installed on the antenna tower assembly.

Manatee County Lift Station standards section 13.03(P) requires that a minimum 300 Watt Response 2:

halogen light or equal be mounted on the RTU system tower for illumination of the lift station area. This light fixture needs to be included for wind load calculations as the structure as a

whole shall be rated for 130 mph winds.
