Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **DELETE** the interactive Excel Bid Form issued with Addendum #3 and **INSERT** the **REVISED** interactive Excel Bid Form that is issued with this Addendum #4.

**The following questions have been presented by potential bidders after the issuance of Addendum #3:**

**Question #1:** Reference to bid form , Pay item 106 the revised bid form shows zero (0) quantity for 18-inch mitered end cross drains, but there are two (2) on the plan sheet 19 at station 63+00 on Ft. Hamer Road, Why is the bid form showing zero quantity?.

**Response #1:** Quantity for pay item no. 106 has been increased from 0 to 2. Quantity for pay item 112 has been decreased from 14 to 12. Please see the **REVISED** interactive Excel bid Form issued with this Addendum #4.

**Question #2:** Reference Addendum Three, Question #29 and its response, does “meet FDOT requirements” mean that the material does not have to be F.D.O.T. certified? Please clarify.

**Response #2:** The material shall be FDOT certified.


