Response 1:

Yes, crushed concrete may be used for base material. The crushed concrete should have a minimum LBR 150 and it should be compacted a minimum of 98% of its maximum dry density as determined by AASHTO T-180. Refer to the **REVISED** General Detail Sheet (Sheet C-9) which is made a part of this addendum.


Quoters note that the Geotechnical Report which was included with the original Request for Quotation also contains this information.
