The work also includes drying of the sediments through the use of sea-based operations, and hauling, delivery and placement of such sediments at the Manatee County Landfill.

Dear Mr. Froman,

Bids for the above referenced project were received on May 5, 2010. A total of five (5) contractors submitted bids. Bid prices ranged from a high of \$1,338,844 (Tampa Contracting Services, Inc.) to a low of \$538,780 (Energy Resources, Inc.), as shown in the attached Tabulation of Bids.

All five proposals included the documentation required by Manatee County to be considered. Per the County's bidding practice, each contractor provided two base bids, "A" and "B". Base Bid "A" is for a completion time of 300 calendar days and Base Bid "B" is for a completion time of 360 calendar days.

Originally, Energy Resources, Inc. was determined to be the apparent low bidder on Bids "A" and "B" in the amount of \$538,780 each. However, after further review and contacts with the contractor, it was determined that Energy Resources, Inc. would not be able to meet the specification requirements. Therefore, this bid was rejected and the remaining bids were re-evaluated.

Based on this re-evaluation of bids, Custom Built Marine Construction, Inc. was determined to be the next apparent low bidder on Bid "A" in the amount of \$783,252, and on Bid "B" in the amount of \$721.260.

We also conducted interviews of the individuals provided as references by Custom Built Marine Construction, Inc. Of the four (4) references contacted, all but one indicated satisfactory completion of work conducted by the contractor, with their projects completed on-time and within or below bid prices.

Based on the information provided with each bid, and in consideration of the terms and conditions set forth in the contract documents, AECOM USA, Inc. recommends that this project be awarded to Custom Built Marine Construction, Inc. for the amount of \$721,260 for completion in 360 calendar days (Base Bid "B"). For completion in 300 days (Base Bid "A"), AECOM USA, Inc. recommends that this project be awarded to Custom Built Marine Construction, Inc. for the amount of \$783,252.

After my phone conversation yesterday with Chuck Froman I would like to present Energy Resource's position on rejecting any award for the Coral Shores Dredging Project. The issue of dewatering as I interpreted it is different from the county's interpretation. Article 2.04 of the specifications states " All dredged sediment shall meet Manatee County Landfill requirements for disposal at those facilities. The Contractor shall use sea based operations for drying of sediment prior to transfer to Manatee County Landfill. Devices used for sea based operations may include use of geotubes, Rotary Fan Press, Belt Press, Hydrocyclone or other such devices on barges."

Our approach de-watered the pulp density from 85% water to 35% water in the barge but still required another day or two of de-watering at the loadout site before the material was to be loaded into trucks. Whereas, I do not interpret this to preclude our operating plan I do understand Chuck Froman's position on this matter given additional input from FDEP and therefore reject the notice of award and withdraw our bid. Energy Resources, Inc. has no plans to contest any award to another bidder.
