### BACKGROUND/EVALUATION

The selected Consultant will provide consulting services for an impact fee update and mobility plan. The Consultant will compile and analyze the technical data, including changes in population, demographics, and other relevant factors required to legally support a new impact fee schedule. In addition, the Consultant will prepare a mobility plan for unincorporated Manatee County, reflecting project and plan coordination within County departments, cities, the MPO and FDOT.
