Division of Blind Services, Bureau of Business Enterprise, Tallahassee, FL – The firm submitted a satisfactory proposal detailing their qualifications and past experience, however the firm did not propose the healthy type snacks which would be acceptable to EHB's Health & Lifestyle Programs as the County continues to promote healthy choices. Additionally, the firm proposed a lesser commission on sales that would be paid to the County then the firm selected.
