NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Pace Dewatering System Ltd. Inc. for the provision of Centrifuge Rental Services.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/EVALUATION

The solicitation was advertised to secure a qualified contractor to provide centrifuge rental services. The Utilities Department has long relied upon mechanically cleaned sludge drying beds to process its alum sludge residuals, with the growth of Manatee County, the sludge drying beds have proven inadequate to sustain the County needs. The County has established centrifuge mechanical dewatering as the preferred technology for this application. The County is constructing permanent solids dewatering facilities, but those permanent facilities are not anticipated to become operational until sometime during the 2024 calendar year.

The solicitation was advertised on June 6, 2022 on the Manatee County website and Periscope S2G. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to their members. Responses were received from the following firms:

2. Synagro South, LLC, Baltimore , MD
