## Addendum 2 is issued to respond to questions received through March 29, 2017. No additional questions shall be considered.

Q1. Referring to Drawings T3.0.00 and T3.0.01 there are device count tables for each rack space. What does the reference "Relay" refer to? Please clarify what it controls.

**R1.** Since the T3.0.00 and T3.0.01 drawings have separate device counts for Intercom Speakers and call buttons, as well as door controls, the only other control item not included would likely be lighting.

The reference to relay in device count tables on drawings sheets T3.0.0.00 and T3.0.01 should be for lighting, HVAC, or other general purpose power control relays. These were copies from Existing Owner "As Built" Record Documents. No further information is available.

Q2. There are counts for both "Speaker" and "Call-In". For example, System 3 – D104 indicates 68 Speakers and 42 Call-In. Are any of the 68 speakers associated with the 42 Call-In? In other words – are there 26 speakers and 42 call-ins with a speaker? If so, then please explain the counts for System 5 – H202 where there are 10 Speakers and 81 Call-In.

Phoesical Management Department Precomment Division 1112 Maname Avenue West, Some 103 Phone outplier, [9471,749-3014 R2. There are more "Speakers" than "Call-In" points because multiple 25v line overhead PA speakers are "daisy-chained" or "serially connected" thru some of the relay board (s) contacts, and thus, speakers in the ceilings do not each have a "Call-In" button. There are more "speaker" points than "Call-In" points for that reason. System 3, for example, covers the kitchen area, medical and a good portion of the main hallway, P.A. wise, so it has 26 "daisy-chains", so to speak, of 25v paging speakers. H202 System 5 only has 5 "daisy-chains" of speakers since it only covers one dorm and a small section of the upstairs hallway.

Q3. There are counts for both "DPS" and "Relay (Door)". For example System 3 – D104 indicates 27 DPS and 23 Relay (Door). Are any of the 23 Relay (Door) part of the 27 DPS? In other words – are there 23 controlled doors that include a DPS and 4 Doors with only a DPS?

R3. There are several keyed lock doors that are DPS only, for example, for plumbing chases and EY emergency fire exists. There is no relay point for release, but there are inputs for DPS so the control consoles can monitor those doors.

Q4. If so, then please explain the counts for System 9 – N202 where there are more Controlled Doors (179) than there are DPSs (146).

R4. The correct number of Controlled Doors "RELAY (DOOR)" for System 9 is 138 NOT 179. Thus the number of "DPS" (146) is greater than the correct number of "RELAY (DOOR)" at 138, as you would expect.

Please, again note that the number of speakers, 168, is greater than the number of call-in buttons, 132, because some intercom zones which have a single call in button have multiple speakers.
