Prospective proposers are reminded that the RFP clearly states that any request for additional information must be submitted to a single contact: Melissa Assha, Contracts & Buyer Manager, Manatee County Purchasing Division. That point of contact will, in turn, work with relevant County staff to provide, or facilitate, any desired information which may be sought. Prospective proposers are also reminded that the RFP incorporates Manatee County's strong prohibition against lobbying or ex parte communications with County officials other than the designated point of contact until a final agreement is approved.

This supplemental notice is being issued to ensure all prospective proposers are fully aware of these matters, and that they conduct their due diligence reviews accordingly. Prospective proposers are reminded that a violation of the RFP process, including improper lobbying or solicitation of information from staff other than the designated point of contact may result in the prospective proposer's disqualification from eligibility to continue in the RFP process, whether pre or post-submission of proposals. These procedures, and harsh penalties for violation thereof, are in place so as to provide a level, fair playing field for all prospective proposers, and to ensure the County has a successful RFP process.
