CLARIFICATION

It shall be the responsibility of all quoters to request any additional clarification of the contents herein from George Earnest, Buyer. Manatee County will make a good faith effort to furnish any clarification by written addendum to all known potential quoters. Quoters shall not accept any verbal or telecommunication explanation as authorized clarification of the contents herein.

PURCHASE ORDER AND INVOICE

A Purchase Order shall be issued as a result of this request for quotation. The Purchase Order will serve as the "notice of award" and "notice to proceed". A lump sum payment will be made for the boat and trailer with submittal of an invoice at the time of delivery and County acceptance. The invoice must be priced per the quote submitted and include the Purchase Order number. **Quoters must list on the Quote Response Form the date deadline they will need a Purchase Order from Manatee County in order to fulfill the delivery requirement.**

**TECHNICAL REQUIREMENTS**

**Boat specifications:**

Carolina Skiff model 198 DLX Tunnel Hull Series with hydraulic steering and a 4" hydraulic jack plate. No alternatives will be accepted.

**Engine specifications:**

Yamaha F90LA engine. No alternatives will be accepted.

**Trailer - Minimum Requirements**

- Aluminum trailer, with torsion axle, capable of transporting and launching the boat as specified.
- Must equal or exceed Continental A2030 2400 aluminum trailer.
- Must meet all State of Florida DOT Trailer Requirements.
- All wiring shall be a minimum of 12 gauge and be color coded to meet DOT/ICC requirements.
- All wiring circuits shall be weather-sealed at connections and junctions. No quick-connects such as "scotch locks" will be accepted.
- Standard wiring connections between primary movers and all trailers and pulled equipment will be RV Type 7 wire spade connectors.

**Performance & Delivery - Minimum Requirements**

- All components must be completely assembled and rigged for immediate utilization upon delivery.
  - All warranted components used in the manufacture of this boat, motor and trailer must have Manatee County Fleet Services listed as the owner and contact.
  - All warranted components used in the manufacture of this boat, motor and trailer must have a warranty start date of June 1, 2014.
  - Delivery to Manatee County Fleet Services, 1100 26<sup>th</sup> Ave East, Bradenton, FL 34208 is requested on or before June 2, 2014.
- Unless otherwise stated within these specifications all materials and techniques used in the mounting of the engine, preparing the boat for use and trailering the boat shall be per industry standard, and be made with first class quality materials. An itemized listing of applicable warrantee's is required to be submitted with all quote responses.
