EXHIBIT 1, SCOPE OF SERVICES, ITEM 1.05 - SCOPE

Successful Offeror shall, at its expense, furnish, install, stock, and maintain commercial grade, automatic Vending Machines at one of the locations designed in Appendix A - Ice Vending Machine Potential Locations, for the purpose of selling ice in unattended areas located within Manatee County. Offeror shall also provide the concrete slab. These services shall be provided 24 hours per day, 365 days per year. Successful Offeror shall be solely responsible for payment of any and all sales tax due for space rental and on the sale of its product.

Change to:

EXHIBIT 1, SCOPE OF SERVICES, ITEM 1.11 - EQUIPMENT REQUIREMENTS (D.)

Only install Vending Machines that are either National Sanitation Foundation and / or National Automatic Merchandising Association (NAMA) certified and/or approved.

Change to:

EXHIBIT 1, SCOPE OF SERVICES, ITEM 1.11 - EQUIPMENT REQUIREMENTS (P.)

Ensure installed Vending Machines are energy efficient in design, have industry standard safety features, a positive vend sensor and are UL listed. The machine, the operator, and the product shall meet the requirements set forth in Florida Statute 500.147 and Florida Administrative Code 5K-4.023.

Change to:

EXHIBIT 1, SCOPE OF SERVICES, ITEM 1.11 - EQUIPMENT REQUIREMENTS (R.)

Ensure that installation of the Vending Machine, <u>concrete slab</u> and other equipment are in accordance with manufacturer standards and, as applicable, the Florida Building Code.

Change to:

EXHIBIT 1, SCOPE OF SERVICES, ITEM 1.11 - EQUIPMENT REQUIREMENTS (S.)

Obtain all applicable permits and licenses required for the operation <u>and placement</u> of the Vending Machines.

QUESTIONS AND RESPONSES:

- Q1. Exhibit 1, pg 1, 1.04 G "water metering" will there be sewer charges included in water bill R1. No.
- Q2. Exhibit 1, pg 1, 1.05 SCOPE "Appendix A" there is no appendix A
- R2. Appendix A Potential Ice Vending Machine Locations is hereby incorporated into the RFO through this Addendum.
- Q3. Exhibit 1, Pg3 1.10 "Testing" states provide Copy to County and FDACS, FDACS does not get a copy. They do there on random/yearly inspections and make copies as they deem necessary.

 R3. Offeror shall comply with the Florida Department of Agriculture and Consumer Services testing requirements.
- Q4. Exhibit 1, pg 3&4, 1.11 D. "NSF and NAMA also "P" -UL listed" I don't believe there are any machines on the market that are UL listed. The Ice Makers and the motors and other electronics like card readers are all UL listed but no the vending machine itself. This was re-worded in the last RFP and state NAMA and/or NSF.

R4. Addressed above.

- Q5. Exhibit 1, pg 5 1.14 A. "Pull machine out and clean behind and under" These machines are anchored to the ground/concrete, they are not movable.
- R5. Cleaning standards are negotiable and shall be discussed during contract negotiations.
- Q6. Who pays the cost of installing electric and water supply?

R6. County will pay for water and electric installation to the concrete pad. Selected Offeror shall be responsible for connection to their equipment.

NOTE: Items that are struck through are deleted. Items that are <u>underlined</u> have been added or changed. All other terms and conditions remain as stated in the Request for Offer.
