BACKGROUND/EVALUATION

At the request of the Public Works Department, the Procurement Division solicited RFP No. 22-R078489BB for the provision of an onboard camera system for the Manatee County Area Transit (MCAT).

Responses were received from the following three firms: 1) IVS, Inc. d/b/a AngelTrax; 2) Safety Vision, LLC; and 3) Transit Solutions, LLC d/b/a TSI Video.

The two shortlisted firms presented to the Evaluation Committee on April 20, 2022 and April 21, 2022. On April 22, 2022, the Evaluation Committee met for final technical evaluations which resulted in a unanimous vote to enter into negotiations with Transit Solutions, LLC d/b/a TSI Video.
