Manatee County will make public at the opening the names of the business entities which submitted a Proposal and city and state in which they reside. No review or analysis of the Proposals will be conducted at the Virtual Proposal Opening.

QUESTIONS AND RESPONSES:

Q1. With our firm already working under agreement 15-0909JE with the County, does that prevent us from submitting a proposal on this project?

R1. Agreement 15-0909JE is a continuing services agreement that is limited to projects with an estimated construction cost of \$4 million or less. As such, all qualified firms may submit a response for this project.

Q2. Is Kimley Horn allowed to submit a proposal, or be on a team, being that they prepared the Conceptual analysis included in the RFQ?

R2. Yes, Kimley-Horn may submit a proposal since the conceptual analysis was made part of the RFQ.

Q3. Has the design PM for the County been assigned to this project, and if so, can you tell me who that is?

R3. The County's Project Manager for this project is Eric Shroyer.

Q4. Attachment B, I, for Tab 9, RFQ requests a list of projects that have been "Constructed and Completed" since September 1, 2010. Please clarify if this is a carry-over from a construction template, and if the list may include projects that have completed final design and are currently in construction.

R4. The list for Tab 9 may include projects that have been fully designed and are currently under construction.

Q5. Is there any planned utility work along the corridor?

R5. There are no future utility projects currently planned for this corridor. Utility work that may be associated with this project would be limited to possible relocations and replacements of old pipe.

Q6. Are there state, federal or LAP funds being used?

R6. There is no state, federal or LAP money associated with the design of this project.

No additional questions will be considered after the issuance of this Addendum No. 1.
