### SECTION A: INFORMATION TO PROPOSERS

PROPOSERS MUST COMPLY WITH THE FOLLOWING INSTRUCTIONS TO BE CONSIDERED FOR SELECTION.

#### A.01 OPENING LOCATION

These proposals will be <u>publicly opened</u> at Manatee County Purchasing Division, 1112 Manatee Avenue West, 8<sup>th</sup> Floor, Suite 803, Bradenton, Florida 34205, in the presence of County officials at the time and date stated on the cover sheet. All Proposers or their representatives are invited to attend.

### A.02 PROPOSAL INFORMATION AND PROPOSAL DOCUMENTS

Request For Proposal documents and the Notices of Intent to Award related to those Proposals are available for download in a portable document format (.PDF) file on the Manatee County web page on the Purchasing tab under "Bids and Proposals". You may access these files using Adobe Acrobat software. You may download a free copy of this software (Adobe) from the County's web page if you do not have.

Manatee County collaborates with the Manatee Chamber of Commerce on distributing solicitations using the Chambers website: http://www.Manateechamber.com. This step is in addition to the posting on Manatee County Government web page.

Manatee County may also use an internet service provider to distribute Bids and Proposals. Participation in the DemandStar system is not a requirement for doing business with Manatee County.

IT IS THE RESPONSIBILITY OF EACH PROPOSER, PRIOR TO SUBMITTING THEIR PROPOSAL, TO CONTACT THE MANATEE COUNTY PURCHASING DIVISION (see contact information on page one of this document) TO DETERMINE IF ADDENDA WERE ISSUED AND TO MAKE SUCH ADDENDA A PART OF THEIR PROPOSAL.

#### A.03 REQUIREMENTS FOR FORMAT AND DELIVERY OF PROPOSALS

Any proposals received after the stated time and date will not be considered. It shall be the sole responsibility of the Proposer to have their proposal delivered to the Manatee County Purchasing Division for receipt on or before the stated time and date. If a proposal is sent by U.S. Mail, the Proposer shall be responsible for its timely delivery to the Purchasing Division. Proposals delayed by mail shall not

be considered, shall not be opened at the public opening, and arrangements shall be made for their return at the Proposer's request and expense.

Proposals must be submitted in the format specified in Section C hereof. The contents of each proposal shall be **separated and arranged with tabs in the same order as listed in the Subsections within Section C** identifying the response to each specific item thereby facilitating expedient review of all responses.

## A.04 CLARIFICATION & ADDENDA

Each Proposer shall examine all Request for Proposal documents and shall judge all matters relating to the adequacy and accuracy of such documents. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the Request for Proposal shall be made in writing through the Manatee County Purchasing Division. The County shall not be responsible for oral interpretations given by any County employee, representative, or agent. The issuance of a written addendum by the Purchasing Division is the only official method whereby interpretation, clarification or additional information can be given.

Addenda shall be posted on http://www.mymanatee.org.

It shall be the responsibility of each Proposer, prior to submitting their proposal, to contact the Manatee County Purchasing Division at (941)748-4501, ext. 3014 to determine if addenda were issued and to acknowledge receipt of same on the Proposal Signature page (Attachment A).

### A.05 SEALED & MARKED

Manatee County requires a total of seven copies of your proposal to be submitted in <u>one</u> sealed package. The contents of your sealed package shall include: **One signed Original (marked Original) and Five (5) Copies (each marked Copy) and One (1) Electronic copy.** The electronic copy shall be in a pdf format and submitted on a CD or USB flash drive which is non-returnable. *All seven copies* **of your proposal shall be identical.** 

Your entire proposal package shall be submitted in one sealed package addressed from your company (name and address) and clearly marked on the outside "Sealed Proposal #15-2343CP Five Year Strategic Plan for Manatee

### A.06 LEGAL NAME

Proposals shall clearly indicate the legal name, address and telephone number of the Proposer (company, firm, partnership, individual). Proposals shall be signed above the typed or printed name and title of the signer. The signer shall have the authority to bind the Proposer to the submitted proposal.

### A.07 PROPOSAL EXPENSES

All expenses for making proposals to the County are to be borne by the Proposer.

### A.08 EXAMINATION OF OFFER

The examination of the proposal and the Proposer generally requires a period of not less than ninety (90) calendar days from the date of the opening of the proposals.

### A.09 DISCLOSURE

Upon receipt, all inquiries and responses to inquiries related to this Request for Proposal become "Public Records" and are subject to public disclosure consistent with Chapter 119, Florida Statutes.

Proposals become subject to disclosure thirty (30) days after the Opening or if a notice of intended award decision is made earlier than this time as provided by Florida Statute 119.071(1)(b). No announcement of review of the offer shall be conducted at the public opening. If the County rejects all offers and concurrently notices its intent to reissue the solicitation, initial offers are exempt until the County provides notice of its intended decision or, thirty (30) days after the opening of the new offers.

Pursuant to Florida Statutes 119.0701, to the extent successful Proposer is performing services on behalf of the County, successful Proposer must:

- a. Keep and maintain public records that ordinarily and necessarily would be required by the County in order to perform the service;
- b. Provide the public with access to public records on the same terms and conditions that the County would provide and at a cost that does not exceed the cost provided in F.S. Chapter 119, or as otherwise provided by law;

- Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law, and;
- d. Meet all requirements for retaining public records and transfer, at no cost, to the County all public records in possession of successful Proposer upon termination of the awarded Agreement and/or PO and destroy any duplicate public records that are exempt or confidential from public records disclosure requirements. All records stored electronically must be provided to the County in a format this is compatible with the County's information technology systems.

### A.10 ERRORS OR OMISSIONS

Once a proposal is submitted, the County shall not accept any request by any Proposer to correct errors or omissions in the proposal.

### A.11 DISQUALIFICATION DUE TO NON-RESPONSIVENESS

Manatee County reserves the right to find that any proposal received which does not contain all of the information, attachments, verification, forms or other information, may be considered non-responsive and therefore be disqualified from eligibility to proceed further in the RFP process.

### A.12 RESERVED RIGHTS

<u>The County reserves the right to accept or reject</u> any and/or all proposals, to waive irregularities and technicalities, and to request resubmission. Any sole response received by the first submission date may or may not be rejected by the County, depending on available competition and timely needs of the County. The County reserves the right to award the contract to a responsible Proposer submitting a responsive proposal, with a resulting negotiated agreement which is most advantageous and in the best interests of the County. The County shall be the sole judge of the proposal, and the resulting negotiated agreement that is in its best interest and its decision shall be final. Also, the County reserves the right to make such investigation as it deems necessary to determine the ability of any Proposer to perform the work or service requested. Information the County deems necessary to make this determination shall be provided by the Proposer. Such information may include, but shall not be limited to: current financial statements prepared by an independent CPA; verification of availability of equipment and personnel; and past performance records.

### A.13 APPLICABLE LAWS

Proposer must be authorized to transact business in the State of Florida. All applicable laws and regulations of the State of Florida and ordinances and regulations of Manatee County will apply to any resulting agreement. Any involvement with any Manatee County procurement shall be in accordance with Manatee County Code Chapter 2-26.

# A.14 CODE OF ETHICS

With respect to this proposal, if any Proposer violates, directly or indirectly, the ethics provisions of the Manatee County Purchasing Code and/or Florida criminal or civil laws related to public procurement, including but not limited to Florida Statutes Chapter 112, Part II, Code of Ethics for Public Officers and Employees, such Proposer will be disqualified from eligibility to perform the work described in this Request for Proposal, and may also be disqualified from furnishing future goods or services to, and from submitting any future bids or proposals to supply goods or services to, Manatee County.

By submitting a proposal, the Proposer represents to the County that all statements made and materials submitted are truthful, with no relevant facts withheld. If a Proposer is determined to have been untruthful in its proposal or any related presentation, such Proposer will be disqualified from eligibility to perform the work described in this Request for Proposal, and may also be disqualified from furnishing future goods or services to, and from submitting any future bids or proposals to supply goods or services to, Manatee County.

### A.15 COLLUSION

By offering a submission to this Request for Proposal the Proposer certifies the Proposer has not divulged to, discussed or compared his proposal with other Proposers and has not colluded with any other Proposer or parties to this proposal whatsoever. Also, the Proposer certifies, and in the case of a joint proposal, each party thereto certifies, as to their own organization that in connection with this proposal:

- any prices and/or data submitted have been arrived at independently, without consultation, communication or agreement, for the purpose of restricting competition, as to any matter relating to such prices and/or cost data, with any other Proposer or with any competitor;
- any prices and/or cost data quoted for this proposal have not been knowingly disclosed by the Proposer prior to the scheduled opening directly or indirectly to any competitor;
- no attempt has been made or will be made by the Proposer to induce any other person or firm to submit or not to submit a proposal for the purpose of restricting competition;
- d. the only person or persons interested in this proposal as principal or principals is/are named therein and that no person other than therein mentioned has any interest in this proposal or in the contract to be entered into; and
- e. no person or agency has been employed or retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees.

## A.16 PUBLIC ENTITY CRIMES

In accordance with Section 287.133, Florida Statutes, a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases or real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

In addition, Manatee Code of Laws Chapter 2-26 Article V prohibits the award of County contracts to any person or entity who/which has, within the past 5 years, been convicted of, or admitted to in court or sworn to under oath, a public entity crime or of any environmental law that, in the reasonable opinion of the Purchasing Official, establishes reasonable grounds to believe the person or business entity will not conduct business in a reasonable manner.

To ensure compliance with the foregoing, the Code requires all persons or entities desiring to contract with the County to execute and file with the purchasing official an affidavit, executed under the pain and penalties of perjury, confirming that person, entity, and any person(s) affiliated with the entity, does not have such a record and is therefore eligible to seek and be awarded business with the County. **Proposer is to complete Attachment "B" and submit with your proposal.** 

## A.17 LOBBYING

After the issuance of any Request for Proposal, prospective Proposers, or any agent, representative or person acting at the request of such Proposer shall not contact, communicate with or discuss any matter relating in any way to the Request for Proposal with any officer, agent or employee of Manatee County other than the Purchasing Official or as directed in the Request for Proposal. This prohibition includes the act of carbon copying officers, agents or employees of Manatee County on email correspondence. This requirement begins with the issuance of a Request for Proposal, and ends upon execution of the final Contract or when the Proposal has been canceled. Violators of this prohibition shall be subject to sanctions as provided in the Manatee County Purchasing Code of Law Chapter 2-26.

### A.18 EQUAL EMPLOYMENT OPPORTUNITY

In accordance with the provisions of Title VI of the Civil Rights Act of 1964 and Title 15, Part 8 of the Code of Federal Regulations, Manatee County hereby notifies all prospective Proposers that they will affirmatively ensure minority business enterprises will be afforded full opportunity to participate in response to

this advertisement and will not be discriminated against on the grounds of race, color or national origin in consideration for an award of contract.

#### A.19 AMERICANS WITH DISABILITIES ACT

The Board of County Commissioners of Manatee County, Florida, does not discriminate upon the basis of any individual's disability status. This nondiscrimination policy involves every aspect of the County's functions including one's access to, participation, employment, or treatment in its programs or activities. Anyone requiring reasonable accommodation for the **public meetings** specified herein (i.e. Information Conference or Proposal Opening), should contact the person named on the first page of this document at least twenty four (24) hours in advance of the activity to request accommodations.

## B.01 BACKGROUND INFORMATION

Manatee County Emergency Medical Services (MCEMS) is a division of the Manatee County Public Safety Department. MCEMS is an organization strongly committed to providing quality pre-hospital medical care to the citizens and visitors of Manatee County. MCEMS's core set of values includes Honesty, Integrity, Commitment, Accountability and Professionalism.

MCEMS works collaboratively with many other local, state and federal agencies on a daily basis to provide services to the people of Manatee County. These agencies include but are not limited to the Health Departments, various Law Enforcement Agencies and Manatee County Area Hospitals.

In addition to MCEMS's daily functions, it also has five Special Teams:

- Honor Guard: The Honor Guard participates in parades and funerals, both within the department and honoring Public Safety personnel from other departments.
- <u>HazMat Team</u>: The HazMat Team works in conjunction with local fire departments to handle hazardous materials incidents.
- <u>SABER or Bicycle Team</u>: SABER or Bicycle Teams are utilized where conventional ambulances cannot gain access such as special events.
- <u>SWAT-Tactical Medic</u>: MCEMS works with the Manatee County Sheriff's Office in providing tactical medics for the SWAT Team. MCEMS has been providing medics to the team since about 1985. Their mission is to respond to tactical situations that require the use of specially trained personnel. Some duties include hostage situations, serving high risk search warrants, or any other volatile situation, where conventional law enforcement personnel are in need of assistance.
- <u>Manatee County Search and Rescue (MCSAR)</u>: MCSAR is comprised of dedicated professionals - all active or interested in all search and rescue disciplines, disaster aid, emergency medicine and awareness education. MCSAR professionals are primarily public safety personnel (EMS, fire rescue, law enforcement) furthering the advancement of professional practice, knowledge, and training in these fields.

MCEMS is soliciting for a qualified professional consulting firm to facilitate, develop and prepare a comprehensive five-year strategic plan incorporating a business planning approach. The objective of the strategic plan is to assist the organization in budgetary planning, staffing and management of current and future programs and resources.

## B.02 SCOPE OF SERVICES

The selected Proposer shall provide all labor, materials, supplies, research and travel necessary to develop and provide MCEMS with a comprehensive five-year strategic plan

that incorporates a business approach to funding, detailing the revenue and expense projections for resources.

MCEMS has limited funding allocated for the completion of this project. Proposers are encouraged to be creative and resourceful in proposing the most cost-effective and efficient solutions for the needs outlined in this RFP.

#### Strategic Plan Development

The development of a credible Strategic Plan for MCEMS is dependent upon the comprehensive efforts utilized to gather sufficient input from the various stakeholders. The selected Proposer shall conduct the following activities:

- Preparatory meetings, large group meetings, small group meetings and interviews with MCEMS staff; members and leadership of ten (10) fire companies; internal customers of MCEMS including but not limited to Emergency Communication Center (ECC) staff and Financial Management/Budget Office; members and leadership of the three community hospitals located in Manatee County; Manatee County Department of Health; and local law enforcement, including but not limited to Manatee Sheriff's Office, Bradenton Police Department and Palmetto Police Department.
- Online Surveys
- Focus Groups
- Follow-up meeting with MCEMS leadership and other County staff to review results
- Analysis of historical and statistical trends impacting the MCEMS

#### Strategic Plan Expectations

The Strategic Plan shall include the following components:

- Results of the information gathering sessions and activities listed above. The results must be categorized in a logical and systematic fashion and incorporated into the Strategic Plan as appropriate.
- Development of charts, graphs and tables to depict historic trends and future projections.
- Assessment of MCEMS's strengths, weaknesses, opportunities and threats.
- Creation of the MCEMS Mission, Vision, and Core Value statements.
- Preparation of a document that confirms the MCEMS Mission, Vision and Core Values.
- Positioning for effective engagement with external partners (state agencies, cities, counties and organizations) as well as the public.

- Establishment of tools for communicating MCEMS's role, purpose and goals to improve organizational culture and ensure MCEMS has a desirable work environment with competitive pay and benefits making it possible to attract top talent.
- Prioritize internal staff development opportunities and quality workplace improvements.
- Business plan with revenue and expense projections for resources over the next five years.
- Identify potential fiscal constraints and opportunities in order to achieve strategic goals and objectives.
- Review budget process for potential modifications.
- Recommendations on staffing, resources and possible additional funding sources for MCEMS such as an emergency fee per household, etc.
- Inventory of current resources and deployment by department and collectively.
- First year detailed Operational Plan.
- Recommendations on a protocol/procedure for the distribution of County impact fees.
- Recommendations on a matrix to monitor the success of MCEMS.
- Identification of the MCEMS strategic goals and objectives for Fiscal Years 2016-2020.
- Prioritization and ranking of the MCEMS programs and services based on their ability to achieve these goals.
- List of short-term and long-term goals and priorities, future strategies, program goals/objectives and management goals/objectives.

## END SECTION B

### SECTION C: FORM OF PROPOSAL

This section identifies specific information which must be contained within each proposal. The contents of each proposal shall be <u>separated</u> and <u>arranged with tabs</u> in the same order as listed throughout Section C identifying the response to each specific subsection and its criterion. These evaluation factors shall determine the successful proposal.

The information provided shall be used to determine those Proposers with perceived ability to perform the Scope of Services as stated in this Request for Proposal which may overall best meet the needs of Manatee County. An oral interview with those Proposers reasonably susceptible of being selected for award may be conducted for the purposes of additional evaluation and clarification of both ability and benefit to Manatee County. See Section D. Selection.

### C.01 MINIMUM QUALIFICATIONS (Licensing) TO BE CONSIDERED

To qualify for consideration, the Proposer(s) must present proof of any licensing or certification which will be required by law to perform the services set out in the scope of services required in this RFP.

Proposals may be presented by a single business entity, a joint venture, or partnership.

Proposers must be licensed to do business in the State of Florida.

Prior to consideration of the Proposals submitted in response to this Request for Proposal, Proposers are to document they have current and verifiable experience overseeing the performance of services described within the scope of services set forth herein.

In the event more than one entity is joining in making this proposal, each entity shall set forth its respective experience and qualifications for those areas the entity intends to perform.

If subcontractors are to be used in your proposal in order to meet the minimum experience requirement, detail the business entity(s), description of the service provided, and provide information in response to each subsection of this Section C in the same level of detail and tabbed order as required for the Proposer.

To validate experience, Proposer shall provide the following details to support his/her relevant past performance.

a. Name and location of the Client and the project, the year of performance and the date the project was fully operational and accepted. Include specific details of the project including the components and subcontractors utilized.

- b. Specify the name, title and telephone number for the Clients contract manager for the project and other persons representing the individual agencies with which your firm's key staff directly worked;
- c. Names of your firm's staff and their direct involvement in the project;
- d. Governmental agency, if any, which verified compliance with its requirements or standards, and the names and telephone numbers of the key persons with direct knowledge of the projects.

After the Manatee County Purchasing Division validates the Minimum Qualifications have been met, those Proposals found to be in compliance will be considered by the evaluation committee.

### C.03 INFORMATION TO BE SUBMITTED REGARDING PROPOSER(S)

Note: Tabs are required to identify each item defined in this Section.

- C.03.1 Provide a description of Proposers' background and size.
- C.03.2 Provide a general statement of qualifications to include Proposers' professional credentials and legal status, and **experience** in providing the service enumerated in this Request for Proposal.
- C.03.3 Proposer shall clearly demonstrate experience and ability. Provide a minimum of three (3) recent **public sector client references**, of similar sized and municipal accounts which the proposer has served in a similar capacity over the past five years and/or is currently serving. Provide a contact person, telephone and fax numbers, and email and mailing addresses.
- C.03.4 Provide an **explanation of the Proposers'** corporate or other structure and governance.
- C.03.5 Detail the **financial capabilities** of Proposer(s) relevant to performing the scope of services. If more than one Proposer is teaming up to file a proposal, any prior work any two or more joint proposers have done before should be detailed.
- C.03.6 Identify each **principal of the firm and other "key personnel"** who will be professionally associated with the County. Do not include personnel that

will not have a key role in providing services. Describe their respective areas of expertise.

- C.03.7 Disclose any ownership interest in other entities involved in these services which might reasonably be selected to perform work under the scope of services set forth in this Request for Proposal. This ownership disclosure shall be included, whether such ownership occurs by the Proposer through a parent, subsidiary or holding company or any other form of business entity. Submit entity names and the percent of ownership for each.
- C.03.8 Submit a **manning level statement** for your organization, detailing how many total employees work for your firm at any one time, including temporary and part-time employees. List the ratio of full-time employees to part-time, and temporary employees. Also include a **subcontractor plan** detailing how subcontractors will be used.
- C.03.9 Provide authorization for a Manatee County auditor and/or financial analysts to have access to your financial records at the primary location of the business entity explained in response to item C.03.5, or such other location as may be agreed, for the purposes of verifying your financial representations, review and assessment of the historical and current financial capacity of your business entity and its expected ability to meet ongoing financial obligations to the County as proposed in this proposal to Manatee County. The County's audit and /or financial analyst agents will report their findings in a summary report to the Manatee County Purchasing Official, which will be placed in the proposal files for subsequent use and review.
- C.03.10 Provide descriptions and documentation of **proposed methodology**. Describe and outline the tasks that the selected Proposer believes are necessary to complete the plan. The outline of the project timeline should span from award of contract to final report including milestones. Be sure to include time in the project schedule.
- C.03.11 Please provide a **schedule of costs** associated with each milestone listed in Section C.03.10 above.

- C.03.12 Provide a listing of current litigation, outstanding judgments and liens.
- C.03.13 Provide **copies of two (2) similar strategic plan documents** completed by your firm in the past five years.
- C.03.14 Submit any other **additional information** which would assist the County in the evaluation of your proposal.

### SECTION D: SELECTION

### D.01 EVALUATION FACTORS

Evaluation of proposals will be conducted by an evaluation committee. The committee's goal will be to identify the proposal which will overall best meet the needs of Manatee County as determined from the proposals received and subsequent investigation by the County. General factors to be applied will be: (1) the perceived ability of the Proposer(s) to perform the Scope of Services as stated in this Request for Proposal in the most timely and efficient manner possible, (2) the legal, technical and financial capabilities of Proposer(s), and (3) the experience of Proposer(s).

These evaluation factors shall determine the successful proposal.

### D.02 RELATIVE IMPORTANCE OF EVALUATION FACTORS

Unless noted, no weight will be assigned to the Evaluation Factors stated above.

#### D.03 PRELIMINARY RANKING

An evaluation committee shall determine from the responses to this Request for Proposal and subsequent investigation as necessary, the Proposer(s) most qualified to be selected to negotiate an agreement.

#### D.04 REVIEW OF PROPOSERS AND PROPOSALS

In-person reviews may be conducted with responsible Proposers who are deemed reasonably susceptible of being selected for award, for the purposes of assuring full understanding of: (a) conformance to the solicitation requirements, (b) the abilities of the Proposer, and (c) the proposal submitted.

Proposers shall be available for presentations to and interviews with the evaluation committee, upon reasonable notification from the Purchasing Division. The date(s) and time(s) of any such presentations / interviews shall be determined solely by the County, and may be closed to the public in the discretion of the Purchasing Official, and to the extent permitted by law.

#### D.05 SELECTION FOR NEGOTIATION

The evaluation committee will make a recommendation to the County Administrator as to the proposer which the County should enter into negotiations. The County Administrator will act upon that recommendation and, if accepted, the successful Proposer will be invited to enter negotiations led by the Purchasing Division.

## D.06 AWARD

Award of an agreement is subject to the successful negotiations and the approval of either the County Administrator or the Board of County Commissioners (as provided for in the current Purchasing Code and Procurement Procedures).

# END SECTION D

### SECTION E: NEGOTIATION OF THE AGREEMENT

### E.01 GENERAL

The following general terms and conditions apply to the proposal submitted for consideration and the subsequent negotiations:

- a. The proposal will serve as a basis for negotiating an agreement, but not compel adherence to its terms or conditions.
- b. Upon submission, all proposals become the property of the County which has the right to use any or all ideas presented in any proposal submitted in response to this Request for Proposal whether or not the proposal is accepted.
- c. All products and papers produced in the course of this engagement become the property of the County upon termination or completion of the engagement.

### E.02 AGREEMENT

The selected Proposer shall be required to negotiate an agreement, in a form and with provisions acceptable to Manatee County.

Negotiated Agreements may or may not include all elements of this RFP or the resulting successful proposal where alternative terms or conditions become more desirable to the County, and the parties agree to such terms.

The parties will negotiate the term of the agreement, and the circumstances in which it may be renewed, assigned or terminated.

The parties will negotiate matters of insurance, liability, record-keeping, auditing, and all other relevant contractual matters.
