A public records request was made for the Engineers Estimate for this project.

The FDOT Construction budgeted amount for # 429867-1-58-01 is \$ 333,149.00

**Comment No. 1: What are there the required Qualifications of the Bidder in order to submit a Bid?**

Response:

Contractors are to remove and replace B.03 Qualifications of Bidders in the original solicitation with the Qualification of Bidders as noted:

The Qualification of Bidders for this solicitation shall read as noted:

A Contractor desiring to bid for the performance of any construction contract located on the National Highway System (NHS) or the State Highway System (SHS) in excess of \$250,000 must be certified by the Department of Transportation as qualified in accordance with Section 337.14(1), Florida Statutes and Rule 14-22, Florida Administrative Code. Any Bid for the performance of any construction contract in excess of \$ 250,000 submitted by a Contractor not certified by the Department of Transportation as qualified shall be declared "IRREGULAR" and will be REJECTED.

The three years requirement for performing this type of work shall remain.

**The deadline for submitting sealed Bids at the Manatee County Purchasing Division, 1112 Manatee Avenue West, Suite 803, Bradenton, Florida 34205 has been extended. The new date is December 20, 2013 at 2:00 PM.**
