QUESTIONS AND RESPONSES:

- Q1. On Page 23 of the IFBC, under Appendix A, Minimum Qualifications, Item 4 states "Bidder must be a Florida Department of Transportation (FDOT) Prequalified Contractor in all of the following classes: (8) Electrical Work and (39) Traffic Signal". Will the County allow the Bidder, or Bidder's subcontractor combined be Florida Department of Transportation (FDOT) Prequalified Contractor to meet the work classes specified?
- R1. No, the Prime Contractor is required to be the prequalified contractor.

- Q2. On Plan Sheet 149 under "TEMPORARY TRAFFIC CONTROL PLAN GENERAL NOTES", Note 1 states "LANE CLOSURES ARE PERMITTED BETWEEN THE HOURS OF 7:30 PM TO 6:00 AM FOR SINGLE LANE CLOSURES IN EACH DIRECTION". Also, "LANE CLOSURES ARE ALLOWED ONLY WITHIN AN ACTIVE WORK ZONE". Does the lane closure cover all the construction of all the improvements proposed on this project?
- R2. Yes, this note covers all construction areas within the project plans limits.
- Q3. Will the County consider allowing the Bidder to perform work during the day?
- R3. The lane closure analysis has been completed for this project and lane closures are limited to nighttime work only as stated in the plans.
- Q4. If so, what improvements can be constructed during the day?
- R4. Any required contract work that does not require lane closure can be performed. If closure is necessary, the situation reverts to the Q3 response above.
- Q5. Does purchasing equipment count as a percentage of work completed?
- R5. No, purchasing equipment does not count as a percentage of work complete on the project.

NOTE:

Deleted items will be struck through, added or modified items will be underlined. All other terms and conditions remain as stated in the IFBC.
