Authorization to award Request for Quotation 17-0350BLS, Advertisement of Property with Delinquent Tax, to the lowest, responsive, and responsible quoter, The Bradenton Herald of Bradenton, Florida, for a total estimated cost of \$1,740.00 annually.

Enabling/Regulating Authority

Florida Statute 50.061, Florida Statute 197.402, and Florida Administrative Code 12D-13.036

Background Discussion

Florida Statute 197.402 and the Florida Administrative Code 12D-13.036 require that the Board of County Commissioners shall select a newspaper for the advertisement of property with delinquent taxes. The Florida Statutes and the Florida Administrative Code further sets forth provisions requiring the Tax Collector to pay all costs of the newspaper charges for advertisements. The Tax Collector then considers the proportionate cost of the advertisements in the delinquent tax collected. A Request for Quotation method of procurement was used to obtain competitive pricing. As a result, three (3) quotations were received as follows: The Bradenton Herald at \$1,740.00 annually; the Business Observer at \$5,100.00 annually; and the Herald Tribune Media Group at \$6,000.00 annually.
