Manatee County, a political subdivision of the State of Florida, (hereinafter "Manatee County" or the "County") will accept request for quotations submittals from individuals, corporations, partnerships, and other legal entities organized under the laws of the State of Florida or authorized to conduct business in the State of Florida

Manatee County invites your participation in the following quotation. The specifications stated herein are of the minimum requirements. All quotes submitted must be in accordance with the General and Technical Specifications.

GENERAL TERMS AND CONDITIONS

QUOTE FORMS

Quotes must be submitted on attached County forms, although additional pages may be attached. Quoters must fully comply with all Quotation Documents, terms, and conditions.

AMERICAN DISABILITIES ACT

The Board of County Commissioners of Manatee County, Florida, does not discriminate upon the basis of any individual's disability status. This non-discrimination policy involves every aspect of the County's functions including one's access to, participation, employment, or treatment in its programs or activities.

CLARIFICATION & ADDENDA

Each quoter shall examine the Request for Quote (RFQ) documents and shall judge all matters relating to the adequacy and accuracy of such documents. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the Request for Quotes shall be made through the Manatee County Purchasing Office. The County shall not be responsible for oral interpretations given by any County employee, representative, or others. The issuance of a written addendum is the only official method whereby interpretation, clarification or additional information can be given. If any addenda are issued to this Request for Quotation, the County will attempt to notify all prospective quoters who have secured same, however, it shall be the responsibility of each quoter, prior to submitting their quote, to contact the Manatee County Purchasing Office (see contact on page 1) to determine if addenda were issued and to make such addenda a part of their quote.

CODE OF ETHICS

With respect to this quote, if any Quoter violates or is a party to a violation of the Code of Ethics of Manatee County per Manatee County Purchasing Code Ordinance 08-43, Article 3, Ethics in Public Contracting, and/or the state of Florida per Florida Statutes, Chapter 112, Part III, Code of Ethics for Public Officers and Employees, such Quoter may be disqualified from performing the work described in this quote or from furnishing the goods or services for which the quote is submitted and shall be further disqualified from submitting any future quotes or proposals for work or for goods or services for Manatee County.

The County anticipates that all statements made and materials submitted in a quote will be truthful. If a quoter is determined to be untruthful in its quote or any related presentation, such quoter may be disqualified from further consideration regarding this Request for Quotation.

COLLUSION

By offering a submission to this Request for Quotation, the quoter certifies that the quoter has not divulged, discussed or compared their quote with other quoters, and has not colluded with any other quoter or parties to this quote whatsoever. Also, quoter certifies, and in the case of a joint quote each party thereto certifies as to their own organization, that in connection with this quote:

- a. any prices and/or cost data submitted have been arrived at independently, without consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices and or cost data, with any other quoter or with any competitor:
- b. any prices and or cost data quoted for this quote have not been knowingly disclosed by the quoter and will not knowingly be disclosed by the quoter, prior to the scheduled opening, directly or indirectly to any other quoter or to any competitor;

- c. no attempt has been made or will be made by the quoter to induce any other person to submit or not to submit a quote for the purpose of restricting competition:
- d. the only person or persons interested in this quote, principal or principals is/are named therein and that no person other than therein mentioned has any interest in this quote or in the contract to be entered into; and
- e. no person or agency has been employed or retained to solicit or secure this contract upon an agreement or understanding or a commission, percentage, brokerage, or contingent fee excepting bona fide employees or established commercial agencies maintained by quoter for purpose of doing business.

DISCLOSURE

Upon receipt all inquiries and responses to inquiries related to the Request for Quotation become "Public Records" and are subject to public disclosure consistent with Chapter 119, Florida Statutes.

Quotes/Proposals become subject to disclosure 30 days after the Opening or if a notice of intended award decision is made earlier than this time as provided by Florida Statute 119.071(1)(b). No announcement or review of the offer shall be conducted at the public opening. If the County rejects all offers and concurrently notices its intent to reissue the solicitation, initial offers are exempt until the County provide notice of its intended decision or, 30 days after the opening of the new offers

DISCOUNTS

Any and all discounts must be incorporated in the prices contained in the quote; and not shown separately. The prices as shown on the quote form shall be the price used in determining award(s).

DISQUALIFYING CRIMINAL MATTERS; CERTIFICATION REQUIRED

A person or affiliate who has been placed on the State's convicted supplier list following a conviction for a public entity crime, as that term is defined in Florida Statute s. 287.133, may not submit a quote, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a quote, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit quotes, proposals, or replies on leases of real property to a public entity; s. 287.017 for CATEGORY TWO for a period of 36 months following the date of being placed on the convicted supplier list. may not be awarded or perform work as a supplier, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity in excess of the threshold amount provided in Florida Statute s.287.017 for CATEGORY TWO for a period of 36 months following the date of being placed on the convicted supplier list.

In addition, the Manatee County Code prohibits the award of any contract to any person or entity who/which has, within the past 5 years, been convicted of, or admitted to in court or sworn to under oath, a public entity crime or of an environmental law that, in the reasonable opinion of the purchasing official, establishes reasonable grounds to believe the person or business entity will not conduct business in a responsible manner; To ensure compliance with the foregoing, the Code requires all persons or entities desiring to contract with the County to execute and file with the purchasing official an affidavit, executed under the pain and penalties of perjury, confirming that person, entity, and any person(s) affiliated with the entity, does not have a such a record and is therefore eligible to seek and be awarded business with the County. In the case of a business entity other than a partnership or a corporation, such affidavit shall be executed by an authorized agent of the entity. In the case of a partnership, such affidavit shall be executed by the general partner(s). A confirming Criminal Matters Certification Affidavit is attached for this purpose.

EQUAL EMPLOYMENT OPPORTUNITY CLAUSE

Manatee County, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 and the Regulations of the Department of Commerce (15 CFR, Part 8) issued pursuant to such Act, hereby notifies all quoters that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit quotes in response to this advertisement and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

IRREVOCABLE OFFER

Any quote may be withdrawn up until the date and time set for opening of the quote. Any quote not so withdrawn shall, upon opening, constitute an <u>irrevocable offer for a period of 90 days</u> to sell to Manatee County the goods or services set forth in the attached specifications until one or more of the quotes have been duly accepted by the County.

LEGAL NAME

Quotes shall clearly indicate the <u>legal name</u>, <u>address</u> and <u>telephone number</u> of the quoter. Quotes shall be <u>signed</u> above the <u>typed or printed name</u> and <u>title</u> of the signer. The signer must have the authority to bind the quoter to the submitted quote.

LOBBYING

After the issuance of any Invitation for Bids or Request for Quotation, prospective quoters, proposers or any agent, representative or person acting at the request of such quoter or proposer shall not contact, communicate with or discuss any matter relating in any way to the Invitation for Bids or Request for Quotations with any officer, agent or employee of Manatee County other than the Purchasing Director or as directed in the Invitation for Bids or Request for Quotations. This prohibition begins with the issuance of any Invitation for Bids, or Request for Quotations, and ends upon execution of the final contract or when the invitation or request has been cancelled. Violators of this prohibition shall be subject to sanctions as provided in the Manatee County Purchasing Code.

MATHEMATICAL ERRORS

Quotes submitted shall be based on the quantities stated on the Quote Form. Quantities shall be used for the comparison of Quotes. Payment to the Supplier will be made based on the actual quantity of work completed and accepted at the date of payment request, in accordance with the terms of the contract.

In the event of multiplication/extension error(s), the unit price shall prevail. In the event of addition error(s), the extended totals shall prevail. All quotes shall be reviewed mathematically and corrected, if necessary, using these standards prior to additional evaluation. Calculations shall be factored to the second decimal point.

MODIFICATION OF QUOTATION DOCUMENTS

If a quoter wishes to recommend changes to the Quotation Documents, the quoter shall furnish in writing, data and information necessary to aid the County in evaluating the request to modify the Quotation Documents. The County is not obligated to make any changes to the Quotation Documents. Unless an addendum is issued as outlined in Article A.04, the Quotation Documents shall remain unaltered. **Quoters must fully comply with the Quotation Documents, terms, and conditions.**

QUOTE EXPENSES

All expenses for submitting quotes to the County are to be borne by the quoter.

REGULATIONS

It shall be the responsibility of the quoter to assure compliance with any OSHA, EPA and/or other Federal or State of Florida rules, regulations or other requirements, as each may apply.

RESERVED RIGHTS

The County reserves the right to accept or reject any and/or all quotes, to waive irregularities and technicalities, and to request resubmission. Also, the County reserves the right to accept all or any part of the quote and to increase or decrease quantities or add related services to meet additional or reduced requirements of the County. Any sole response received by the first submission date may or may not be rejected by the County depending on available competition and current needs of the County. For all items combined, the quote of the lowest responsive, responsible quoter will be accepted, unless all quotes are rejected. The lowest responsible quoter shall mean that quoter who makes the lowest quote to sell goods and/or services of a quality which conforms closest to or most exceeds the quality of goods and/or services set forth in the attached Quotation Documents or otherwise required by the County, and who is fit and capable to perform the quote as made.

To be <u>responsive</u>, a quoter shall submit a quote which conforms in all material respects to the requirements set forth in the Request for Quotation. To be a <u>responsible</u> quoter, the quoter shall have the capability in all respects to perform fully the contract requirements, and the tenacity, perseverance, experience, integrity, reliability, capacity, facilities, equipment, and credit which will assure good faith performance. Also, the County reserves the right to make such investigation as it deems necessary to determine the ability of any quoter to deliver the goods or service requested. Information the County deems necessary to make this determination shall be provided by the quoter. Such information may include, but shall not be limited to: current financial statements, verification of availability of equipment and personnel, and past performance records.

TAXES

Manatee County is exempt from Federal Excise and State Sales Taxes (F.E.T. Exempt Cert. No. 59-78-0089K and FL Sales Tax Exempt Cert. No. 51-02-027548-53C); therefore, the quoter is prohibited from delineating a separate line item in his quote for any sales or service taxes. Nothing herein shall affect the quoter's normal tax liability.

BLANKET ORDER

Blanket Purchase Order(s) shall be issued as a result of this request for quotation. A Blanket Purchase Order number, when accompanied by a valid Release Order number provided by an authorized County employee will authorize purchases on an "As Required" basis.

END OF GENERAL TERMS AND CONDITIONS

SPECIFIC TERMS & CONDITIONS

PURPOSE

It is the intent of the County of Manatee to enter into an agreement with a contractor for the service and maintenance of radio towers. This work is critical to public safety and submittals will only be considered from firms with successful experience running a program of preventative maintenance and repair service to multiple communication towers. The Contractor shall provide all materials (except as otherwise stated), equipment, labor, supervision and incidentals required to maintain lights, antennas, transmission lines, and the structural integrity of communications towers and antenna sites as described herein. All work performed on site shall be done by the Contractor's employees.

QUALIFICATIONS OF THE CONTRACTOR

The Contractor shall have been in this line of business for at least three (3) years in the state of Florida. All quoters must submit with their quote the Questionnaire/References form included herein. The Contractor shall be licensed in Florida as a Specialty Tower Contractor and provide that information on the Questionnaire/Reference form. All service personnel shall by uniformed (with visible personal identification) and the Contractor shall possess certification with the National Association of Tower Erectors (NATE) under the Safety Training Accountability and Reliability (STAR) program. Absent the NATE "STAR" program, Contractors shall provide proof of training as per the SAFETY term under the MINIMUM TECHNICAL SPECIFICATIONS section of this RFQ. In order to ensure compliance with the County's service response requirement, the Contractor must have service personnel based within 100 miles of Manatee County.

PRICES & TERM

Quotes shall be inclusive of all materials, labor, transportation, and equipment associated with the maintenance and service of radio towers as specified herein. When applicable, the Contractor shall be responsible for furnishing all necessary permits as required by Manatee County or any state or federal authority prior to commencement of any work or services under the scope of this agreement.

RENEWAL

If not cancelled by the Contractor or the County, this agreement shall be automatically extended/renewed beyond the first twelve (12) month period for four (4) additional twelve (12) month periods not to exceed total contract duration of sixty (60) months providing there are no changes of prices, terms or conditions. Written notice of intention not to renew must be submitted by the successful bidder 90 days prior to the end of a contract period. Should any Contractor choose not to renew the agreement the County reserves the right to terminate the Contract with that Contractor and select the next qualified quoter, or re-advertise for those bid items, or solicit a new RFQ for all items.

CANCELLATION

The County reserves the right to terminate a contract by giving 30 days written notice of intention to terminate if at any time the Contractor fails to abide by or fulfill any of the terms and conditions of the Contract. The County also reserves the right to terminate this contract for the convenience of the County, with or without cause. Failure to adhere to all terms and conditions of the contract may be just cause for the County to dispose of all batteries collected during the balance of the period covered by the contract on the open market and charge any loss occasioned thereby to the Contractor and cancel the agreement without further notice.

It is mutually understood and agreed that any award made as a result of this quote may be cancelled by the Contractor upon 60 days written notice by Certified Mail to the County. However, the County is hereby authorized to secure services, in accordance with the RFQ terms, during this 60 day interim provided the County requests collection during this period.

ASSIGNMENT OF CONTRACT (RESTRICTIONS ON SUBCONTRACTING)

The Contractor shall not assign, transfer, or otherwise dispose of this contract or his right, or his power to execute such contract, or to assign any monies due or to become due there under to any other person, firm, or corporation unless first obtaining the written consent of the County.

UNSUCCESSFUL SERVICES

In the event the work performance of the Contractor is unsatisfactory, the Contractor will be notified by the County and given a time frame to correct the work. There will be no cost to the County for these corrections. If work is not corrected, or if the Contractor fails to perform any required service within the time frame given, the County reserves the right to obtain the service of an alternate Contractor. Deductions of the cost of such substitute will be made from the Contractor's payments. Exemptions may be given by the County if notified of any delays, problems or conflicts that may arise during the course of a particular project. Repetitive unsatisfactory performance shall result in the termination of contract and a transfer of the award to the next lowest responsive and responsible Contractor.

BASIS OF AWARD

Award shall be to the responsive, responsible quoter meeting specifications and having the lowest Total Quote Price. Contractors must quote all items for their quote to be considered responsive. Prices submitted shall include costs for furnishing all labor, equipment and/or materials for the completion of the Work in accordance with all specifications and requirements as listed herein. The County reserves the right to make multiple awards.

Whenever two or more quotes are equal with respect to price, quality and service, the quote received from a local business shall be given preference in award. Whenever two or more quotes which are equal with respect to price, quality and service are received, and both quotes or neither of these quotes are received from a local business, the award shall be determined by a chance drawing conducted by the Purchasing Office and open to the public.

Local business is defined as a business legally authorized to engage in the sale of the goods and/or services to be procured, and which certifies within its bid that for at least six (6) months prior to the announcement of the solicitation of bids it has maintained a physical place of business in Manatee, Desoto, Hardee, Hillsborough, Pinellas or Sarasota County with at least one full-time employees at that location.

END OF SPECIFIC TERMS AND CONDITIONS

MINIMUM TECHNICAL SPECIFICATIONS

SAFETY

The Contractor is solely responsible for the proper training and safety of all personnel performing tower maintenance services under the scope of this contract. The Contractor shall be certified with NATE under their STAR program. Contractor's not certified with NATE's STAR program must prove (upon request) that training in safe climbing practices, radio frequency (RF) exposure safety and be familiar with the Federal Communications Commission Office of Engineering & Technology (FCC OET) Bulletin 65; Guidelines for Human Exposure has been provided. The Contractor shall be responsible to provide OSHA approved climbing and fall protection devices, calibrated personnel RF safety monitors and other safety devices required for personnel protection for the performance of tower maintenance services. Personnel performing services under the scope of this contract shall provide a signed statement that they have received and understood safety training on fall protection and RF exposure.

SERVICE RESPONSE REQUIREMENTS

The Contractor shall respond and begin work for regular repair services within ten (10) calendar days of a request. These services shall be conducted within normal business hours; Monday thru Friday between 8:00 AM and 5:00 PM.

The Contractor shall respond and begin work to emergency repair services within 24 hours of notification. These services may need to be completed outside of the normal business hours as noted above.

Both regular and emergency repairs shall be diligently carried out to completion and the satisfaction of the County. Repair technicians shall not be removed from County projects for other obligations the Contractor may have without prior notification to the County and the County's approval.

HOURLY RATE

The billable time for the Contractor's personnel shall begin when the crew arrives at the first County site location facility and is allowed between each Manatee County site location facility during an authorized visit. Otherwise, billable time ends when the crew leaves a County site at completion of the maintenance or repair job. The Contractor's technicians shall notify the appropriate County staff as to arrival and finish times. The County reserves the review and question time charges that do not match County records.

REQUIREMENTS FOR COMPLIANCE WITH GOVERNING AUTHORITIES

All applicable work shall comply with FAA Circular AC70/7460-1K. In addition, all maintenance and repairs shall comply with the most recent TIA/EIA-222 guidelines.

MATERIALS

Unless otherwise specified the County will supply materials and equipment. However, the Contractor shall provide all materials and expendable supplies needed for correction of minor deficiencies, routine maintenance and repair such as lamps/bulbs and tower hardware (nuts, bolts, washers, clamps, etc.). Additional costs for materials, supplies, and repair parts shall be separately itemized and pre-approved by the County at the markup percentage rate as quoted in the Quote Price Form.

ITEMIZED PRICING

The County requires pricing on the quote form for the following items. The County does not know and cannot offer an estimate of the number of times these services may be required within a year. For quote tabulation purposes each item will have a multiplication factor of one for a quantity. Quoters are required to provide pricing for each item listed on the Quote Price Form for their submittal to be considered complete and responsive.

- 1. Six to twenty foot long Onmi antenna removal.
- 2. Six to twenty foot long Onmi antenna installation.
- 3. Six to twenty foot long Onmi antenna and feed line removal. 1/2" to 7/8"
- 4. Six to twenty foot long Onmi antenna and feed line installation. 1/2" to 7/8"
- 5. Six to twenty foot long Onmi antenna and feed line removal. 1 5/8"
- 6. Six to twenty foot long Onmi antenna and feed line installation. 1 5/8"
- 7. Six to twenty foot long panel antenna removal.
- 8. Six to twenty foot long panel antenna installation.
- 9. Six to twenty foot long panel antenna and feed line removal. 1/2" to 7/8"
- 10. Six to twenty foot long panel antenna and feed line installation. 1/2" to 7/8"
- 11. Six to twenty foot long panel antenna and feed line removal. 1 5/8"
- 12. Six to twenty foot long panel antenna and feed line installation. 1 5/8"
- 13. Microwave dish installation. 2-3 foot diameter.
- 14. Microwave dish removal. 2-3 foot diameter.
- 15. Microwave dish installation, 4-6 foot diameter.
- 16. Microwave dish removal. 4-6 foot diameter.
- 17. Microwave dish installation. 2-3 foot diameter including feed line and elliptical.
- 18. Microwave dish removal. 2-3 foot diameter including feed line and elliptical.
- 19. Microwave dish installation. 4-6 foot diameter including feed line and elliptical.
- 20. Microwave dish removal. 4-6 foot diameter including feed line and elliptical.
- 21. Microwave dish alignment 2-3 foot.
- 22. Microwave dish alignment 4-6 foot.
- 23. FAA tower lighting repair rate per hour for normal business hours. Plus materials as per % markup.
- 24. FAA tower lighting repair rate per hour for emergency/after hours. Plus materials as per % markup.
- 25. Tower inspections labor rate, as per the Tower Service Procedures below. Plus materials as per % markup.
- 26. Tower maintenance labor rate, as per the Tower Service Procedures below. Plus materials as per % markup.
- 27. Non-emergency service hourly labor rate tower crew. Plus materials as per % markup.
- 28. Emergency service hourly labor rate tower crew. Plus materials as per % markup.

EMERGENCY SERVICE

The Contractor shall provide labor for emergency antenna repair or replacement. This may also include climbing assistance to isolate defective antennas and transmission lines utilizing test equipment. Since the County towers support Public Safety Communications, downtime is critical, therefore all requests for emergency service shall be honored expediently with a maximum response time of 24 hours from time of notice. The Contractor shall provide upon request a 24/7 contact number(s) and email address for emergency notifications.

Additionally the Contractor shall provide service for lighting system malfunctions within 72 hours notice. Emergency service includes weekend and/or after hour labor for inspections or emergency lighting repairs to communications sites.

Emergency Services shall include (but not be limited to) the following:

- 1) Provide labor for the repair of lighting systems, to include lamps, fixtures, and controls. Lamps/bulbs to be supplied by the Contractor.
- 2) Provide labor for the testing and repair of transmission lines and connectors.
- 3) Provide labor for the repair or replacement of defective antennas.

TOWER MAINTENANCE AND INSPECTION PROCEDURES

The frequency of inspections shall be annual but shall also be provided upon request. Some of the items listed below may apply only to initial construction of new towers.

Tower Conditions (guyed and self-supporting)

- 1) Members:
 - a) Bent members (legs and lacing).
 - b) Loose members.
 - c) Missing members.
 - d) Climbing facilities, platforms, catwalks -- all secure.
 - e) Loose and/or missing bolts.
- 2) Finish;
 - a) Paint and/or galvanizing conditions.
 - b) Rust and/or corrosion conditions.
 - c) FAA or ICAO color marking conditions.
 - d) Water collection in members (to be remedied, e.g., unplug drain holes, etc.).
- 3) Lighting;
 - a) Conduit, junction boxes, and fasteners weather tight and secure.
 - b) Drains and vents open.
 - c) Wiring conditions.
 - d) Controllers functioning:
 - I) Flasher.
 - II) Photo control.
 - III) Alarms,
 - e) Light lenses.
 - f) Bulb condition (option: change all bulbs at one time).

- 4) Grounding;
 - a) Connections checked and secure.
