## BACKGROUND/DISCUSSION

- This procurement is for fitness equipment for the Manatee County Parks and Natural Resources, GT Bray fitness facility.
- The intent of this Request for Quotation (RFQ) is to establish a single award to the lowest, responsive, responsible quoter meeting specifications.
- The County solicited Request for Quotation #16-3274BLS from November 8, 2016 through November 14, 2016, appropriate quotation procedures were followed.
- Notice of RFQ #16-3274BLS was directly solicited to four quoters, solicited on MyManatee.org, and the Manatee County Chamber.
- Three quotations were received from: Commercial Fitness Products Inc.; Gym Source USA, LLC; and Promaxima Manufacturing.
- Subsequent review of quotations received from Commercial Fitness Products Inc. and Promaxima Manufacturing were deemed non-responsive as they did not meet all specifications (see attachment).
- November 29, 2016, received an email from Jeff Lightburne, Fitness and Wellness Supervisor recommending award to Gym Source USA, LLC.
