BACKGROUND/DISCUSSION

- The Work included in this Request for Quotes consists of furnishing all labor, materials, equipment and incidentals required to provide bi-annual preventative maintenance, load bank testing and limited repairs of standby generator systems at various County facilities for a three year period.
- The contract provides for any necessary repairs, outside of the preventative maintenance, to be performed at an hourly rate plus the cost of repair parts.
- As a result of competitive quote procedures, a total of five (5) quoters submitted a quote response for consideration. Please refer to the attached quote tabulation for the breakdown of the quotes received.
- These services are funded in the General Fund from various accounts of the operating budgets of the Property Management Department's building management funds.
- On December 5, 2016 a recommendation was received from the Property Management Department recommending award to Ring Power Corporation of Sarasota, FL
