The following items are issued to add to, modify, and clarify the Request for Proposals (RFP) documents. These items shall have the same force and effect as the original RFP documents. Proposals are to be submitted on the specified date, on or before the specified time and shall conform to the additions and revisions listed herein.

1. **Question:** Does this RFP include environmental services associated with your EPA Brownfields Assessment Grant?

**Answer:** No.

2. **Question:** Who are the incumbents of this contract?

3. **Question:** How many firms will you select for this contract?

5. **Question:** Who will be on the evaluation/selection committee?

**Answer:** The selection for the evaluation committee has not been finalized.

6. **Question:** Does this contract replace the contract awarded in 2015 for asbestos and indoor air quality work?

**Answer:** No.

7. **Question:** Are there any Minority Business Enterprise (MBE) requirements?

**Answer:** Please refer to Section C.03.8 of the RFP which states "State if your firm is a certified Minority Business Enterprise in the proposal and, if so, provide a copy of that certification."

8. **Question:** Due to the number of elements included in the scope of work, do we need to cover EVERY area outlined in Section B.02?

**Answer:** If there are areas of work that your firm cannot handle, please include those areas in the proposal. If sub-consultants are to be used in your proposal to handle those areas then detail the business entities, description of the service provided, and responses in the same level of detail and tabbed order as instructed in the Request for Proposal for the Proposer.

9. **Question:** Is there a Local Preference – Added Points for being a local firm?


**Answer:** Please refer to the response to Question 4 above.
