## QUESTIONS AND RESPONSES:

**Q1. Please provide all permits which have been procured for this project.**

R1. Approved permits for ERP (43018891.001) and U.S. Army Corp (SAJ-2024-01251) will be provided to awarded bidder.

**Q2: There is no Pay Item for milling, please confirm where we should include the milling required per the contract plans.**

R2. Pay Item **327-70-2** will be added for 265 SY of **3½"** milling.

**Q3. The pay item quantity for Turbidity Barrier is 37 LF, please note the takeoff quantity based on the erosion control contract drawings is significantly higher.**

R3. The turbidity barrier will be revised to a quantity of 2,184 ft.

**Q4. Pay Item 550-102-10 – Fencing Type B has a bid quantity of 546 LF. The only fencing we found on the plans is on DWG 18 and 20, adjacent to North Pond, please provide the location for the remainder of the fencing required for the project.**

R4. Please see Sheet 39 for the impacts to the existing fence during Phase II of the TTCP.

**Q5. Please confirm the Contractor must include a schedule with the Bid Documents to be considered responsive.**

R5. Provide a schedule based on 370 days as required by Section A.43 as part of the Basis of Award.

**Q6. Please provide the as-built plans for the structure to be demolished.**

R6. No existing bridge plans are available, only previous bridge sketches, see attached. One of the details is from a previous design project.

**Q7: Will the County supply the geotechnical consultant for pile driving, including, but not limited to, inspection, monitoring, and reporting?**

R7. A Geotechnical consultant will be provided by the County.

**Q8. How will the County address pile driving overruns or underruns regarding production pile lengths? Will they adhere to FDOT specifications for FY 2024-25?**

R8. FDOT Specification FY 2024-2025 will be followed for determining pile quantities.

**Q9. The quantity for item 400-2-5 Concrete Class II, Bridge Substructure seems incorrect at 19.8 cy. We estimate approximately 55.6 cy total. Please advise.**

R9. The quantity will be revised to 54.9 CY.

**Q10. The plans and specs both reference a Maintenance of Traffic Pay item yet one is not provided in the bid schedule. Can one please be added via addendum?**

R10. A Pay Item 201~~500~~-001 will be added for Maintenance of Traffic.
