- Q1. Please provide the last bid result and the awarded contractor.
- R1. RFQ 14-0697GE Intent to Award is attached to this Addendum No. 1.
- Q2. In order to price this fairly and accurately please provide the number of Systems, the total number of Water Flow and Tamper Switches and the number of floors at each building site.
- R2. Refer to site information attached to this Addendum No. 1.
- Q3. Since the spec say we are to provide audible testing at each site is the county providing someone to operate the Fire Alarm Systems or are we providing that 2nd person? If we are providing please state that for all other bidders as well.
- R3. Contractor shall provide adequate staff to perform the service requested.
- Q4. I'm reaching out in regards to the Fire Sprinkler System And Hydrant Inspection, Maintenance and Repair project (19-R070779JE) to see if there are any union requirements, an estimated value, or an estimated start date for the project.
- R4. There are not any union requirements. Start date would be upon award.
- Q5. The bid documentation details the type of system (i.e. Wet Pipe/Dry Pipe) for each of the (37) buildings however it does not provide site specific detail needed to estimate the job. Lacking this information would require a detailed on-site survey of each building to get an accurate scope of work. Some of the information needed would be the number of standpipes, number of risers, backflow preventers, backflow by-pass, fire pump etc. Will the County provide this information within an addendum?
- R5. Refer to site information attached to this Addendum No. 1.
- Q6. Can the County provide a copy of previous inspection reports for each building?
- R6. This information is will be provided on a need to know basis to the awarded supplier.
- Q7. I would like to find out the list of bidders and award amount that was approved for the existing contract. Is there somewhere on the website that I can find this information as part of the public records?
- R7. Refer to Q1.
- Q8. Can you please provide me with the result from the last time this was put out to Bid?
- R8. Refer to Q1.
- Q9. Can you please advise what months the inspections are due for each location?
- R9. Refer to site information attached to this Addendum No. 1.
- Q10. The scope says annual inspections but per NFPA 25 sprinkler inspections are required quarterly, what is the winning bidder responsible for?
- R10. We are currently required to have annual inspections per the local fire officials.
- Q11. The scope says annual inspections but per NFPA 25 Electric Fire pumps are required to have monthly Churn test, what is the winning bidder responsible for?
- R11. We are currently required to have annual inspections per the local fire officials.

Q12. The scope says annual inspections but per NFPA 25 Diesel Fire pumps are required to have
weekly Churn test, what is the winning bidder responsible for?

R12. We are currently required to have annual inspections per the local fire officials.

- Q13. In the General Requirement it mentions "Five year inspections as required". Please advise when the 5 year was last done on each system at each location.
- R13. This information is not available for most sites, but plan on providing one 5-year inspection for each site during the term of this agreement.
- Q14. Can you provide Tabulation sheets and Letter of award from last bid? R14. Refer to Q1.
- Q15. Can you provide any information on number of risers each building (Possibly last year Inspection Reports)?

R15. Refer to site information attached to this Addendum No. 1.

Q16. We don't see any mention of backflows on the bid. Most sprinkler systems are tied to a backflow. What is the winning bidder responsibility when it comes to backflows?

R16. Backflows are handled under a separate contract.
