- 09/30/2011 to 11/16/2011 appropriate bid procedures were followed. The IFB was broadcasted via DemandStar and the Manatee Chamber of Commerce to more than five hundred ninety-one (591) prospective bidders and suppliers and was published on the Manatee County website. Fifty-six (56) vendors are listed as planholders, of which five (5) are located within Manatee County.
- Eight (8) firms submitted a bid for this Invitation for Bid; four (4) of the bidders are local firms, three (3) within Manatee County.
- This project is funded under the American Recovery and Reinvestment Act, Recovery Zone Economic Recovery Bonds (RZ-EDBs). Estimated start of construction is 03/29/2012 with completion within three hundred and thirty (330) days for an estimated completion date of 02/22/2013.
- The three (3) low bidders are as follows:
