**RFQ** No. 22-TA003923RP is amended as set forth herein. Responses to questions posed by prospective bidders are provided below. This Addendum is hereby incorporated in and made a part of 22-TA003923RP.

The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to this RFQ is January 28, 2022.

### **QUESTIONS AND RESPONSES:**

- Q1. The light pole CONCRETE BASE, is this in the electrical contractor scope of work or will be on the concrete contractor scope.
- R1. This is at the discretion of the Proposer.

#### Q2. Is this a Davis bacon job with special rate or normal pay rate.

R2. Davis Bacon Act, as amended (40 U.S.C. 276a to a-7) – Contractor is required to comply with the Davis-Bacon Act (40 U.S.C 276a to a-7) and as supplemented by Department of Labor regulations (29 CFR part 5, "Labor Standards Provisions Applicable to Contracts governing Federally Financed and Assisted Construction"). Under this Act, Contractors shall be required to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in a wage determination made by the Secretary of labor. In addition, Contractors shall be required to pay wages not less than once a week. (See Exhibit 8 Current Federal Wage Decision attached to this Addendum No. 1).

### Q4. Can you please provide a duration or a completion date for this project?

R4. Proposer must commit to a timetable of no more than 486 calendar days for substantial completion of the project.

## Q6. Will there be a price due with this proposal on February 11<sup>th</sup>?

### Q7. Please provide form 10 need for Trench Safety?

R7. Form 10, Florida Trench Safety Act is attached to this Addendum 1.

# **Q8. Since the MOT work is minimal is an Advanced MOT person really needed?** R8. Yes.

- Q9. Since 100% drawings will not be available until March, please describe what scope of work in the preconstruction phase is expected from the contractor?
- R9. The Construction Manager-at-Risk (CMAR) will be required to perform due diligence in thoroughly reviewing the plans and specifications provided with the County Project Management team and the design team and provide opportunities for value engineering with the final deliverable being the Guaranteed Maximum Price (GMP). The CMAR will also be responsible for any outstanding permits if any.

The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed

in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

#### Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

#### Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.
