## Lobbying Limitation

Lobbying prohibition limits communication between:

 Prospective bidders or their agents, representatives, or persons acting at the request of such bidder

and

 County officers, agents or employees other than the Procurement Official (e.g., County Commissioners, County Administrator, County Consultants)

Includes copying such person on written communications but does not apply to a commission meeting where the Commission is considering approval of a proposed contract.

#### Due Diligence Evaluation of Bids

- During the due diligence review, bids are evaluated to determine whether each Bidder is responsive and responsible.
- A responsible Bidder means a Bidder that meets the qualification requirement(s) of this IFBC.
- A responsive Bidder means a Bidder has submitted a Bid that conforms in all material respects to the requirements in the IFBC.



- Bidder must be registered with the State of Florida. Division of Corporations to do business in Florida.
- Bidder must submit a statement on company letterhead and signed by an authorized official of Bidder that Bidder, or its representative(s), has made an inspection of the construction site, listing the date of the inspection and the individuals, by name, who conducted the inspection.
- Not on the Florida Department of Management Services Convicted, Suspended, Debarred Vendor List



- Bidder must provide a copy of Bidder's General Contractor license or Underground Utility Contractor Licenses issued by the Florida Department of Business and Professional Regulation and documentation confirming Bidder has been licensed and/or certified for the period of June1, 2018 through the date of submission of the Bid.
- Bidder must submit a copy of Bidder's Qualifying Agent's registration or certification along with supporting documentation confirming Qualifying Agent has been the Qualifying Agent for Bidder for two (2) years, since June 2019.

- Bidder has provided gravity sewer replscement for at least three (3) projects since June1, 2018 in which each project included the following components: (i) gravity sewer replacement; (ii) installation of new gravity sewer mains, manholes and service laterals; (iii) excavation, trenching, back filling and all appurtenant work as required. Project clients must be agreeable to responding to an inquiry by the County.
- Provide the following information for the three (3) qualifying project references.
  - a) Name of client
  - b) Project name
  - c) Location (City/State)
  - d) Client contact name
  - e) Contact phone
  - f) Contact email
  - g) Service dates (Start/End)

- If Bidder is not a joint venture, provide a statement to that effect. If Bidder is a joint venture, provide a copy of Bidder's approved filing with the Florida Department of Business and Professional Regulation.
- If no conflicts of interests are present, Bidder must submit a statement to that affect. Submit a fully completed copy of Appendix J. If applicable, on a separate page disclose the name of any officer, director or agent who is also an employee of the County. Disclose the name of any County employee who owns, directly or indirectly, any interest in the Bidder's firm or any of its branches.

#### Scope of Work

- The Scope of work consists of constructing approximately 4400 liner feet of 8-inch to 12-inch gravity sewer installed by open cut, 550 liner feet of 8-inch gravity sewer, installation of 23 proposed manholes, removing and reconnecting approximately 93 service laterals to the proposed sanitary sewer. Additionally, the project includes restoration of sidewalks, driveways, and pavement.
- This project will be completed in Phases; Phase one (1) must be complete before starting Phase two(2).
- Construction areas located on private property of homeowners
  CANNOT take place without a Right of Entry agreement. The
  COUNTY will obtain those Right of Entry agreements.

#### ACCESSIBILITY REQUIREMENTS

- All of electronic information, documents, applications, reports, and deliverables (INCLUDING YOUR BID SUBMISSION) must be in a format that meets the requirements of Section 508 of the Rehabilitation Act and best practices (W3C WCAG 2).

- 5% Bid Bond
- 100 % Performance and Payment Bond
- Liquidated Damages \$730.00 per day
- Engineer's estimate = \$3,997,901.00
- The completion time frame is: 670 calendar days for "A" and 760 calendar days for "B"

- Delivering the response after the deadline.
- Failing to provide the information requested for the "Minimum Qualifications"
- Not presenting questions regarding minimum requirements, scope/specifications, terms and conditions, or other provisions prior to the deadline for delivery of questions.



#### Mistakes That Could Cost You!

- Providing information that is not legible, too small or blurry
- Failing to acknowledge addenda
- Failing to sign the response
