NOTICE OF INTENT TO NEGOTIATE

Notice of Intent to Negotiate with Urban Transportation Associates, Inc. (UTA), Cincinnati, Ohio to provide Automated Passenger Counting Equipment on Manatee County Area Transit Fixed Route Buses for the Public Works Department.

BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

The Manatee County Board of County Commissioners (BCC) currently provides a public transportation program through Manatee County Area Transit (MCAT). MCAT provides 13 fixed-route bus routes and advance-reservation paratransit (Handy Bus) service to unincorporated Manatee County, Bradenton, Ellenton, Palmetto, Sarasota, and the Gulf beaches. MCAT improves the quality of life for Manatee County residents and visitors by providing, in a cost-efficient manner, a readily-accessible, intermodal means of mobility.

MCAT is required to collect and submit annual ridership data to the Federal Transit Administration (FTA) as part of the National Transit Database (NTD) reporting requirement. Currently, the data is collected manually, which is time consuming and can be inaccurate. The NTD report development process is currently very labor intensive and costly to prepare because the manually collected data does not provide the level of detail necessary to understand ridership patterns, running time for each bus trip and accurate vehicle load counts. Additionally, inaccurate data could have an adverse effect the funding MCAT receives annually.

SOLICITATIONS:

The RFP was advertised on the Manatee County website, DemandStar, and was also provided to the Manatee County Chamber of Commerce for release to its members. One (1) proposal was received.

There were no **Manatee County** firms directly solicited and none that submitted a proposal.

EVALUATION RESULTS:

The Evaluation Committee (the "Committee") convened on December 19, 2014 to review evaluation committee responsibilities, discuss member's availability for future meetings, and the Florida Sunshine Law as applicable to public meetings. The Evaluation Committee then proceeded to review the one (1) proposal received for its responsiveness to the requirements of the RFP. As a result of the discussion, the Committee determined that the proposal was both responsive and responsible. Based on the content of the proposal the Committee felt there was adequate information to vote. The committee unanimously agreed that Urban Transportation Associates, Inc. be recommended for an "Intent to Negotiate" award to the County Administrator.

Urban Transportation Associates (UTA), Inc. Cincinnati, Ohio – UTA demonstrated exceptional qualifications in their proposal. The proposal was both responsive and responsible, meeting all necessary criteria set forth in the RFP. UTA's system will provide MCAT with the ability to generate the necessary reporting functions for the National Transit Database (NTD). UTA has extensive experience in this field and has installed their equipment at over ninety transit agencies.
