RFP 18-R068672GD IS AMENDED AS SET FORTH HEREIN. RESPONSES TO QUESTIONS POSED BY PROSPECTIVE PROPOSERS ARE PROVIDED BELOW. THIS ADDENDUM IS HEREBY INCORPORATED IN AND MADE A PART OF RFP NO. 18-R068672GD.

QUESTIONS AND RESPONSES:

- Q1. The warranty on the installation is 12 months, but the Biamp product has a 5-year warranty. Is the four remaining years going to be treated as a depot warranty whereby Manatee County is responsible for de-install, ship and reinstall or will the integrator provide this for a total of five vears?
- R1. Yes, the four years remaining will be treated as a depot warranty by Manatee County.
- Q2. It states that if the job is over \$200K, a performance and payment bond is required for "construction projects". As we discussed in today's mandatory meeting, that no bonds are required. Please confirm that this is not considered a construction project for bonding purposed?
- R2. The County does not require a performance and payment bond for this Biamp Upgrade, as this is not a construction project.
- Q3. Will you be sending out a list of questions that everyone asked or will the only way to find the answer to all questions asked to be to go to the websites questions and answers?
- R3. As stated during the Information Conference the County will provide in an Addendum written

responses to clarification questions submitted in writing to the County by the Clarification Question due date.

- Q4. Will Manatee County be sending out drawings for the existing system?
- R4. The County provided the drawings documentation in Addendum No. 2.
- Q5. Does the county have uncompiled code for AMX touch panels?

R5. Yes.

- Q6. Will the integrator be responsible for de-installing the existing non-used Biamp equipment?
- R6. The successful Proposer will be responsible for the de-installing of the old Biamp equipment.
- Q7. Was the Biamp configuration designed in house or by a consultant?
- R7. The Biamp configuration was done originally by the vendor. Then modified in-house by the County.

NOTE: Items that are struck through are deleted. Items that are underlined have been added or changed. All other terms and conditions remain as stated in the RFP.
