

**Question 1:** Can we directional drill 2 – 3 feet below the main trunk elevations to avoid interference with the sewer laterals going to the homes?

## Response 1:

In general, the County always wants the mains installed as shallow as possible for ease of accessibility for any future maintenance. We understand that existing subsurface conditions and existing infrastructure typically play an important part in determining the appropriate alignment and depth of the installation.

The County is in the process of conducting a sanitary sewer lateral inspection that will determine the locations and depths of the existing sanitary sewer laterals crossing 48th Ave E and 18th St E. The County will provide all resulting data/reports to the successful Contractor to assess the proposed bore path. Prior to installation of the HDPE force main, the successful Contractor shall meet to discuss any proposed revisions to the designed alignment and depth of the proposed bore path to reduce the potential for any conflicts with the existing underground sanitary sewer lateral infrastructure.
