

BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

- The Board of County Commissioners has approved issuance of a revised Request For Proposal solicitation document with an expanded scope of services which includes a provision for allowing consideration of accessory lodging along with the finance, design, construction, operation, maintenance and marketing of an aquatic & recreation complex.
- At its February 9, 2016 public meeting, the Board of County Commissioners approved issuance of a new solicitation with an expanded scope of services provides the basis for the decision to reject all proposals, and such action is in the best interest of the County. In addition to this direct courtesy notice, and as required by Manatee County Code § 2-26-42, this notice will be published and posted in the same manner as notice of the initial solicitation.
- The Parks and Natural Resources Department shall review, amend, and update the proposal scope of services. Upon completion of the updated proposal scope of services, the Request for Proposals shall be re-issued.
