#### **QUESTIONS AND RESPONSES:**

Q1. Why is there a 4000 SY difference between cold in place and milling? The plans seem to show that all areas getting milled are also getting cold in place. There is no differentiation.

- R1. There is 3933SF bridge deck area that does not need cold in place base. The quantity of cold in place base has been updated. Please see Appendix K, Bid Pricing Form Revised.
- Q2. Type S-3 Asphalt quantity also seems off. No additional areas are shown getting a 1" overlay. At 51015 SY and 110lbs/SY, there should only be about, 2805 tons.
- R2. The asphalt quantities for both S-1 and S-3 have been adjusted. Please see Appendix K, Bid Pricing Form Revised.
- Q3. Please identify the lane closure restrictions for this project.
- R3. Due to high traffic volumes, lane closures are ONLY permitted from 9 AM 2 PM.
- Q4. Please expand on the extent of the bridge repairs. It is being assumed that the county will be doing the joint repair themselves.
- R4. The bridge joint repair will be handled by Manatee County maintenance crew. Please coordinate with County before the construction.
- Q5. Pay item number 35 appears to be mislabeled. The pay item number coincides with FDOT pay item "PULL & SPLICE BOX, F&I, 13" x 24" COVER SIZE", yet it is labeled as "Polymer Concrete Adjustment Ring" please confirm.
- R5. Item 35 is for Pull & Splice Box, PULL & SPLICE BOX, F&I, 13" x 24" COVER SIZE. The label is a TYPO. Please see Appendix K, Bid Pricing Form Revised.
- Q6. Can you please provide a bid form in excel format for submission?
- R6. Excel format of Appendix K Bid Pricing Form Revised (Fillable) is available for download as a separate attachment.
- Q7. Please expand on the County's intent about "add 2 warning signs and striping" to the traffic separators. There is no requirement or standard for signs and markings on a traffic separator, so the contractor will need clarification on what the county wants.
- R7. The intent is to hatch out the extra room left between the lane and the traffic separator and provide the warning sign at each end. See below picture as an example.

- Q8. Please identify on the plans where the patterned textured pavement is to go.
- R8. Pay Item 523-3 Patterned Pavement is in relation to the Green-Colored Pavement Markings for use in the bicycle lanes as identified on the plans as a grey colored hatch, shown adjacent to right-turn lanes and at intervals along the roadway. Length of patterned pavement to be determined from stationing shown on the plans.
- Q9. Will bituminous liquid adjustment be applied to this project?
- R9. No adjustment.
- Q10. Please confirm if the side streets on this project will get milled and resurfaced?
- R10. Limits will be as shown per plan.
- Q11. Will we be required to provide a signed and sealed MOT plan for this project?
- R11. If the FDOT standards are followed, no signed & sealed plan is required. If there is any deviation from those standards, then a signed & sealed plan is required.
- Q12. The file "22-TA004390LP Bid Attachment 3 100% Plans 75<sup>th</sup> St W Cortez Rd Bridge- 134094 8-31-22.pdf" is missing the utility adjustment sheet and details. Will you please provide these missing plan sheets?
- R12. Revised Bid Attachment 3, Proposed Roadway Plans for 75<sup>th</sup> St W Rebase is available for download as a separate attachment.
