<u>Bid</u> "B" completion schedule will require all work outside of the seagrass transplanting to be substantially complete within 210 calendar days.

QUESTIONS AND RESPONSES:

- Q1. Reference specifications Appendix A, Minimum Qualifications, par. 4, the requirement to provide references since March 4, 2017 is too stringent and we ask consideration be made to relax this requirement and ask that references for the past ten (10) years be allowed.
- R1 See revisions made to Appendix A above.
- Q2 Reference specifications Appendix A, Minimum Qualifications, par. 4, will a dredging subcontractor be allowed to be a part of the references to meet this requirement?
- R2. See revisions made to Appendix A above.
- Q3. Reference bid form, Items 10.1, 11.1 and 11.2, how are we to quantify this work when the unit of measure for each of these bid items is Lump Sum?
- R3. Reference Measurement and Payment sections D.1.10 and D1.11 for mangrove and seagrass respectively as well as the mitigation plan found in Attachment 7 of the USACE permit for this project located in Bid Attachment 4 Permits, part 5 of 5.
- Q4. Reference specifications, Bid Attachment 2, SPECIFICATIONS/MEASUREMENT AND PAYMENT, page D-11, par. D.1.9.2, PRODUCTS, sub-par. Polyvinyl Chloride Pipe (PVC), this paragraph tells us for pipes sizes 4-inch through 10-inch the pipe shall be Schedule 40 and meet the requirements of ASTM D-3034, SDR-35 or ASTM F-949, these pipe, although they are all PVC, are not the same as Schedule 40 PVC, which one of these types of pipe are we to use for the 8-inch bid item, 9.3?
- R4. Please note that Bid Item 9.3 should read 8" PVC and not 8" PCP. 8" Schedule 40 PVC pipe meeting the requirements of ASTM D-2665, ASTM F-1866 and 8" PVC pipe meeting the requirements of ASTM D-3034, SDR-35, ASTM F-949 are acceptable for Bid Item 9.3.
- Q5. Reference plan sheet 8 of 19, at Str. R#1, a Type C Inlet, there is a run of 24" PCP labeled P2B-2, 130LF long, but there is no bid item for this type of pipe. Please clarify.
- R5. PCP is listed in Section D.1.9.2 of the Bid Attachment 2 Measurement and Payment and Item No. 9.7 of the Bid Form list 240LF of 24" PCP. However, the quantity of the 24" PCP should be 265LF instead of 240LF which is made up of a 135LF run of 24" PCP labeled P2B-2 at STR R#1 and a 130LF run of 24" PCP labeled P2B-7 at STR D#1.
- Q6. Reference plan sheet 7 of 19, the removal pipeline CE6, an existing 36" CAP with Flapgate, it is hard to define the length of this run of pipe, can a length be provided?
- R6. Estimated 40 LF, previously removed by others.
- Q7. Reference plan sheet 8 of 19, the removal of pipeline CE2, an existing 16" PVC, unable to determine the length of this pipe run, please provide the length.
- R7. Estimated 25 LF, previously removed by others.
- Q8. Reference plan sheet 8 of 19, the removal of pipeline CE5, an existing 24" DIP, unable to determine the length of this pipe run, please provide the length.
- R8. Estimated 40 LF.

Q9. Reference plan sheet 8 of 19, the removal of pipeline CE4, an existing 30" RCP, unable to determine the length of this pipe run, please provide the length.

R9. Estimated 20 LF.

Q10. Reference plan sheet 8 of 19, the removal of pipeline CE3, an existing 24" RCP, unable to determine the length of this pipe run, please provide the length.

R10. Estimated 40LF.

Q11. Reference Bid Form, Bid Item 9.11, Existing Culvert (PCP, CAP, DIP) Removal and Disposal, the bid quantity is for 8-each, plans show 10-each, please revise bid quantity.

R11. If you count the removal of the Bridge 1 Temporary Land Bridge temporary culvert (estimated to be 40LF of 36" PCP) on Sheet 8 separate from the removal of the land bridge, then the bid quantity for Bid Item 9.11 should be 11. However, since CE6 and CE2 have already been removed by others, the actual bid quantity for Bid Item 9.11 would be 9 as shown in the "Bid Item 9.11 – Existing Culvert (PCP, CAP, DIP) Removal and Disposal Schedule" below assuming that the Bridge 1 temporary land bridge removal (aka excavation) is separate from the temporary culvert removal from the excavation of this land bridge.
