Background Discussion

The Solid Waste Division of the Utilities Department has a requirement for a vendor to supply and deliver an estimated 205,000 cubic yards of solid waste cover dirt to the Lena Road Landfill for use as daily operational cover material. Formal, competitive sealed bid procedures were followed resulting in a total of three (3) bidders submitting a sealed bid for consideration.

Dakin Natural Soil Inc.'s unit price of \$5.61 per cubic yard includes the cost of the material and hauling to the landfill for the contract term. Dakin Natural Soil Inc.'s stated source selection of material is located at 9801 289th Street East in Myakka City, Florida.

After bid analysis and testing of the dirt samples from their proposed source location, the Solid Waste Division of the Utilities Department provided their recommendation for award to Dakin Natural Soil, Inc., for an estimated total bid amount of \$1,150,050.00.


